**A RESOLUTION OF THE CITY OF SANTA CLARA,

WHEREAS, to comply with the California Code Regulations section 570.5, the City of Santa Clara shall among other things, have publicly available pay schedules approved and adopted by the City Council which shall indicate an effective date and date of any revisions; and

WHEREAS, as required by the California Code Regulations section 570.5 and as mandated by CalPERS, the City Council deems it to be in the best interests of the City to adopt the Amended Unclassified Salary Plans for elected positions to reflect salary modifications approved and adopted by the Salary Setting Commission, with an approval date of July 7, 2026, and an effective date of July 1, 2026.

NOW THEREFORE, BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

1. That the City hereby adopts the Amended Unclassified Salary Plan for the positions of Mayor, City Council Member, and City Clerk, reflecting the wage increases previously approved by the Salary Setting Commission.
