



Measure I Overview

Measure I: Addressing Critical Infrastructure Needs

- Voter Approval: Approved by Santa Clara voters on November 5, 2024.
- Authorization: Authorizes up to \$400 million in general obligation infrastructure bonds.
- Addressing Unfunded Needs: Aims to address over \$600 million in unfunded infrastructure needs, including:
 - Aging fire stations
 - Storm drain systems
 - Aquatic facilities
- Clear Path Forward: Provides essential funding for repairs and improvements across Santa Clara, prioritizing projects within the approved Expenditure Plan.
- Ensuring Transparency: Requires the establishment of a Bond Compliance Oversight Committee (COC) for accountability.



Role and Responsibilities of the Bond Compliance Oversight Committee (COC)

- Core Functions of the COC:
 - Project Alignment: Ensure project implementation aligns with all bond measure requirements, including the Expenditure Plan.
 - o Audit Review: Review and report on annual audits of bond expenditures.
 - Expenditure Plan Amendments: Review and provide recommendations to the City Council on proposed amendments to the Expenditure Plan.
 - Public Information: Inform the public about the expenditure of bond proceeds.
- What the COC Does NOT Do (Per Proposed Bylaws):
 - Establish priorities or order of project implementation.
 - Approve project design.
 - Select project consultants or contractors.
 - Select Measure I auditors.
 - Note: These functions remain with the City in accordance with procurement standards and City Council ultimate approval.

- Committee Composition (9 Members):
 - o 1 Large Business Representative (50+ employees) 4-year term
 - 1 Small Business Representative 2-year term
 - o 7 Santa Clara Residents, representing specific districts/at-large with initial terms:
 - District 1 (2-year term)
 - District 2 (4-year term)
 - District 3 (2-year term)
 - District 4 (4-year term)
 - District 5 (2-year term)
 - District 6 (4-year term)
 - At-Large Member (4-year term)
- Recruitment Timeline: Application Period: March 18, 2025 April 29, 2025.
- Recruitment Update:
 - May 6, 2025: Sole eligible Large Business applicant withdrew.
 - o Action: New recruitment for Large Business Representative is underway.

Alternate Member Role & Proposed Bylaws

- City Council Determination Requested for Alternate Members:
 - Option 1: Active Alternate Member: Attend and participate in COC meetings in place of primary member when primary is absent.
 - Option 2: Stand-By Alternate Member: Attend and participate only if/when the primary member resigns or vacates their position.
- Proposed Bylaws:
 - Meeting Frequency: Will meet as needed. Anticipated to meet no more than 4 times a year.
 - o First Meeting Scheduled: June 4, 2025.
 - o Term: Up to two four-year terms.
 - Duties of the COC: Inform the public; Review Proposed Phases and Expenditures; Annual Report; and Review and Recommendation for Amendments to the Expenditure Plan
 - City Council Authority: Retains authority approval of all project-related actions including contracts, expenditure of the bond funds, project prioritization, and approval of the sale of the bonds.
