# CONSENT TO ASSIGNMENT AGREEMENT BY AND BETWEEN THE CITY OF SANTA CLARA, CALIFORNIA, AND ERNIE AND SONS SCAFFOLDING AND UNIQUE SCAFFOLD

(Formerly known as Ernie and Sons Scaffolding Service dba Unique Scaffold)

## **PREAMBLE**

This consent to assignment agreement ("Consent Agreement") is by and between the City of Santa Clara, California, a chartered California municipal corporation, with its principal place of business located at 1500 Warburton Avenue, Santa Clara, California 95050 ("City"), Ernie and Sons Scaffolding, doing business as Unique Scaffold, a California Corporation, with its principal place of business located at 1960 Olivera Road, Concord, CA 94520 ("Ernie and Sons" or "Assignor") and Unique Scaffold, a California Corporation, with its principal place of business located at 2501 Annalisa Drive, Concord, CA 94520 ("Unique Scaffold" or "Assignee"), the intended successor in interest to Unique Scaffold. City, Ernie and Sons and Unique Scaffold may be individually referred to in this Consent Agreement as a "Party" or collectively as the "Parties" or the "Parties to this Consent Agreement."

## RECITALS

- A. City and Ernie and Sons entered into an agreement entitled, "Agreement by and Between the City of Santa Clara, California and Ernie and Sons Scaffolding Services dba Unique Scaffold,", dated October 1, 2021 (the "Original Agreement") in which Ernie and Sons agreed to provide scaffolding services to the City;
- B. Section 8 of the Original Agreement entitled <u>No Assignment of Agreement/Successors in Interest.</u> provides as follows:
  - "City and Contractor bind themselves, their successors and assigns to all covenants of this Agreement. This Agreement shall not be assigned or transferred without the prior written approval of City. Contractor shall not hire subcontractors without express written permission from City.
  - Contractor shall be as fully responsible to City for the acts and omissions of its subcontractors, and of persons either directly or indirectly employed by them, as Contractor is for the acts and omissions of persons directly employed by it."
- C. Ernie and Sons desires to have the City consent to the assignment of all rights, obligations and interest in the Original Agreement from Ernie and Sons to Unique Scaffold;

In consideration of the above referenced recitals and the following mutual covenants, commitments and obligations, the Parties agree, as follows:

### CONSENT AGREEMENT PROVISIONS

- 1. Based on a written request received by the City from Unique Scaffold, City hereby consents to the assignment of the Original Agreement and all of the rights, duties, obligations and interest set forth therein from Ernie and Sons to Unique Scaffold. This consent is based on representations made by Unique Scaffold and Ernie and Sons and all the duties and obligations of Ernie and Sons to perform specified services included in the Original Agreements shall be performed by Unique Scaffold after the Effective Date. This Consent is effective as of the completion of the Effective Date.
- 2. City acknowledges and relies on this acceptance by Unique Scaffold of all of the rights, obligations and interest in the Original Agreement and the relinquishment of all such the rights, obligations and interest in the Original Agreement by Ernie and Sons. Unique Scaffold hereby accepts such assignment from Ernie and Sons, effective as of the Effective Date, assumes and agrees to be bound by all applicable terms of the Original Agreement, and agrees to perform all the duties and obligations and assume all liabilities and responsibilities of Ernie and Sons, except as set forth herein.
- 3. Upon the Effective Date, any pending debts or obligations due to City and those which subsequently arise or accrue from the terms and conditions of the Original Agreement shall become payable by Unique Scaffold to the City or its agents, or assigns.
- 4. This Consent Agreement embodies the entire agreement between City, Unique Scaffold and Ernie and Sons and all of its terms and conditions regarding the matter contained herein. No verbal agreements or conversation with any officer, agent or employee of City prior to execution of this Consent Agreement shall affect or modify any of the terms or obligations contained in this Consent Agreement. Any such verbal agreement shall be considered as unofficial information and in no way binding upon City.
- 5. As a condition of the terms of this Consent Agreement, Unique Scaffold shall provide the City with the following:
  - a. Revised Certificate of Insurance, as well as all policy endorsements to indicate that Unique Scaffold has purchased, and is maintaining, all of the required insurance policies and has provided the required endorsements which were included in the terms and conditions of the Original Agreement.
- 6. This Agreement may be executed in counterparts, each of which shall be deemed to be an original, but both of which shall constitute one and the same instrument; and the Parties agree that signatures on this Agreement, including those transmitted by facsimile, shall be sufficient to bind the Parties.

The Parties to this Consent Agreement hereby acknowledge and accept the terms and conditions stated herein by the following signatures of their duly authorized representatives. The signature of the duly authorized representative of Unique Scaffold confirms its acceptance of the terms and conditions of the Original Agreement and the assignment of the Original Agreement from Ernie and Sons. The Effective Date is the date that the final signatory executes the Agreement. It is the intent of the Parties that this Agreement shall become operative on the Effective Date.
