Commissioner Forte asked if the team presenting will be recommending a preferred bike lane option that would be used or will they be letting the public provide feedback to which they prefer. Nicole He responded that as part of community outreach, the public is being asked about which option(s) they prefer. The community survey that was just posted, prompts the public support or select one of the concepts. The summary of the comments will be presented to the Bicycle and Pedestrian Advisory Committee (BPAC) for consideration. In January 2024, BPAC will decide on their preferred alternative for this project.

**Commissioner Chu** asked about the Benton Street traffic impact since two lanes will be closed, and if there is an existing bike lane on Martin and Walsh. Nicole He stated that the traffic impact is part of the study and was also a concern of the community. Traffic results from the study will be shared with the public and BPAC. Lafayette Street will be the connection to Martin and Walsh, which Ralph Garcia stated is a different project.

**Commissioner Gupta** asked about greenery/landscaping along the paths. According to Nicole He, the scope of the project is for conceptual design, and landscaping in the immediately adjacent area is not part of the project.

### **STAFF REPORT**

**Acting Director Seale** advised the Commission of the following: Westwood Oaks Park Playground to break ground the first week of October. For safety, the whole park will be closed for the duration of construction for about six/seven months; no impact to recreation programming. Non-native eucalyptus trees have been removed and the trees will be replaced as part of the rehabilitation project. The contractor will display the schematic design on the fence for the neighbors to visualize the scope of rehabilitation project. Park patrons are recommended to visit nearby neighboring parks to recreate: Jenny Strand, Homeridge, and Maywood parks. Montague Park - building renovation is almost complete; the park portion, improved playground, exercise equipment are now available to the public. A soft opening is expected in late October 2023. The kickoff for Parks & Recreation system-wide Master Plan for the City of Santa Clara's park system will be starting soon. The Master Plan will involve every single community, commissions, stakeholders, and will address funding, programming, future capital projects, and a roadmap for the park system development over the next 15-20 years. This comprehensive study will take up to 12-14 months to complete. The next Facility Condition Assessment will be done within the time frame of the Master Plan.

Recreation Manager Castro advised the Commission of the following: Encouraging the Commission to provide feedback on the 41st annual Art & Wine Festival. The Department is getting ready for the production of Tarzan. Senior Center hours were extended in July and there is an increase in attendance as a result. The Recreation Team is getting ready for Winter programming; after-school programs continue to be strong; last of the Concerts in the Park series will be on Friday, September 29, 2023 at Live Oak Park; State of the City will be on Wednesday, September 27, 2023; Children's Halloween, Saturday, October 28, 2023; and Holiday Tree Lighting, Friday, December 1, 2023.

### **COMMISSIONERS REPORT**

Chair Caldwell joined the Senior Center and toured the facility and was very impressed. Visited Fremont Park; went to the Concert in the Park in Central Park; volunteered at the Art & Wine Festival. Commented on how a crisis was addressed by the commissioners, and staff, including Police - quick response time, and compassionate care with the concerned party. He commended all involved in the response effort.

**Commissioner Chu** visited Henry Schmidt Park; looking forward to hearing more information regarding Agnews Historic Park restroom hours - a concern brought about by her neighbor; volunteered at the Art & Wine Festival; expressed the need to order more glasses for next year; and she is looking forward to attending the last of the Concerts in the Park series for 2023 at Live Oak Park.

**Commissioner Forte** volunteered at the Art & Wine Festival on Saturday and Sunday. Derek Bryant brainstormed with commissioners in real-time, for next year's Art & Wine Festival.

**Commissioner Gupta** volunteered at the Art & Wine Festival - people were even buying lots of vintage glasses.

**Vice-Chair Hai** missed the Art & Wine Festival; he is excited about the Westwood Oaks Park playground rehabilitation project; visited Jenny Strand Park.

### **SUBJECT**

Consideration of the Schematic Design - Master Plan for the New Public Neighborhood Park at 2200 Calle Del Luna (Holland Partner Group - Tasman East Specific Plan)

### **COUNCIL PILLAR**

Enhance Community Sports, Recreational and Arts Assets Deliver and Enhance High Quality Efficient Services and Infrastructure Enhance Community Engagement and Transparency

#### **BACKGROUND**

The Santa Clara City Code 17.35 requires new residential development to provide parkland and active recreational amenities (and/or fees in lieu) to serve the needs of residents in the immediate neighborhood of the development and to reduce potential impacts on the City park system. The review and approval process includes several steps. Residential developer applications are submitted to the City. Parks & Recreation Department staff review the application for conformance with the requirements of City Code, the park system facility, program and service needs, research based best practices, park design principles, standards and specifications, as well as compatibility with any City adopted specific plan and adjacent property uses. Following an internal review, a proposed park program and initial schematic design are presented for community input by stakeholders, the public and the Parks & Recreation Commission. The process involves public meetings, an on-line survey, and other opportunities for feedback. A revised/preferred park master plan and schematic design are then presented to the Parks & Recreation Commission for recommendation to the Santa Clara City Council (Council) for review and approval.

On November 13, 2018, City Council adopted the Tasman East Specific Plan which provides guidelines for projects proposed within the 45-acre specific plan area bounded by Tasman Drive to the south, the Guadalupe River to the east, the Related Santa Clara development to the north, and Lafayette Street to the west. The Specific Plan provides detailed guidance for future land uses.

On October 16, 2019, the City approved a redevelopment application from the Holland Partner Group to construct 580 dwelling units on a 3.9-acre site within the Tasman East Specific Plan. The project involves the construction of two 12-story buildings and one 11-story building over a podium with three levels of parking, private recreational amenity spaces, and a neighborhood park. The Project will meet its parkland dedication requirements through the dedication of a 1.09-acre (44,649sf) public neighborhood park (Neighborhood Park), eligible private recreational amenities, and payment of City Mitigation Fee Act (MFA) fees due in-lieu of parkland dedication in compliance with City Code 17.35. The Project's 1.09 acres of improved parkland will also satisfy the Tasman East Specific Plan (TESP) pro rata requirement of the River District park space. The Neighborhood Park will be designed and constructed by the developer, dedicated to the City in fee title, and will be maintained in perpetuity by

the developer after dedication to the City.

On August 15, 2022, the Parks & Recreation Commission received a presentation of the proposed schematic design and amenities for the Neighborhood Park, received public comment and provided Commission input (RTC #23-849). The proposed Holland park dedication will be sited adjacent to the future, not yet designed, Related development park dedication. Since the two public park parcels will be developed and dedicated to the City at separate times by different entities, the preferred outcome is to have a single cohesive park experience for the new neighborhood.

### **DISCUSSION**

At the October 17, 2023 meeting, the Parks & Recreation Commission will receive a presentation (Attachment 1) by Holland Partner Group for the Neighborhood Park Schematic Design - Master Plan at 2200 Calle De Luna in response to the community input.

### **Community Outreach**

Community input included a Community survey that was posted on the City's Park Projects webpage [Park Projects | City of Santa Clara (santaclaraca.gov) <a href="https://www.santaclaraca.gov/our-city/departments-g-z/parks-recreation/park-projects">https://www.santaclaraca.gov/our-city/departments-g-z/parks-recreation/park-projects</a>] after the Commission Meeting from August 18 through September 10, 2023. Notice was announced at the Commission Meeting and an email was sent using the City's GovDelivery system.

### **Public Input**

The community responded favorably to the initial schematic park design. Some of the highly requested features including shade, lighting, gathering spaces, and a walking/running loop were already part of the initial schematic park design. The schematic design addresses the community's priorities as follows:

- Shade and Planting: The extensive tree canopy with an estimated 50+ trees will provide plenty
  of shade. The adjacent residential building will provide protection from the late afternoon sun.
  The public was presented with four potential planting schemes for the park, all using primarily
  climate-ready native plants. The preference was for the two more "lush" schemes ("Cool
  Purples and Whites" and "Shades of Green") which will inform the final plant palette.
- Park Lighting: The park will be fully lighted through a combination of overhead light poles, bollards, and tree uplighting fixtures.
- Gathering spaces: The park features numerous spaces for gathering for all ages and abilities.
  There are tables and chairs and benches scattered throughout the park which offers ample
  seating opportunities. In addition, the playground invites children and adults to explore natural
  elements together.
- Circulation: The park is organized along a continuous walking path that weaves through the
  park and links to the larger open space network within Tasman East via two connection points
  at Lick Mill Blvd. When combined with the landscaped sidewalk along Lick Mill Blvd., the
  walking path forms a continuous quarter-mile loop.

The Commission will review the Schematic Design, receive public comment, and make a possible recommendation to City Council for approval.

### **ENVIRONMENTAL REVIEW**

The action being considered does not constitute a "project" within the meaning of the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines section 15378(b)(5) in that it is a governmental organizational or administrative activity that will not result in direct or indirect changes in the environment. The activity covered by this residential development project falls within the scope of the project analyzed under the Environmental Impact Report (EIR) for the Tasman East Specific Plan which included the construction of parks, which was approved on November 13, 2018 (Resolution No. 18-8623) pursuant to the California Environmental Quality Act (CEQA) (Public Resources Code Section 21000 et seq.).

### **FISCAL IMPACT**

There is no fiscal impact to the General Fund for the construction of the Neighborhood Park. The developer will design and construct the Neighborhood park to City standards, and maintain the park in perpetuity, at no cost to the City.

### COORDINATION

This report has been coordinated with the City Attorney's Office.













The Work Plan Goals for FY2022/23 were: A: 1) Review park site and facility condition assessments and recommend priorities given existing and anticipated service levels and available resources; B: 1) Review and solicit community input on the existing City park rehabilitation projects based on the current Capital Improvement Program (CIP) Budget and schedule; and 2) review residential developer proposed schematic designs for new neighborhood parks that serve new residential development; C: 1) Host and develop recommendations for the annual Santa Clara Art & Wine Festival 2023; and 2) participate in Citywide Special events; and D: 1) Partner with at least one other City commission to build on/expand at least one existing Parks & Recreation event by adding one extra element for patrons to interact with during the event.

At the September 2023 Regular Meeting, the Commission reviewed Work Plan goals from prior years and discussed potential goals and activities to include in the Commission Work Plan for FY2023/24.
