GENERAL BUSINESS

- 1 [25-1722](#) Discussion and Action on Potential Revisions to City Charter Section 1012 and Section 1013 for Consideration by the Charter Review Committee

Recommendation: Action to direct staff to draft talking points consistent with the Board's discussion and take any other action necessary to facilitate a meeting between Chair Evans, as the Board's appointed representative, and the relevant Charter Review Ad Hoc Subcommittee.

City Librarian Wong introduced the recommended process of having the **Board** review the charter and ordinance powers and duties for the **Board of Library Trustees**, and sorting them into three buckets: roles the **Board** would like to maintain, roles the **Board** might like to maintain or add, and roles the **Board** are not as interested to maintain. The **Board** held discussion on the Anaheim City Charter section 908 pertaining to their library board's powers and duties for reference and context, as it had been previously reviewed by the **Charter Review Committee**. They discussed all the current **Board** powers and duties as described in the Santa Clara City Charter sections 1012 and 1013 and Ordinance 2.120.080, and sorted them into three buckets. The **Board** agreed to revisit these at the regular February 2, 2026 meeting for additional discussion and finalization.

A motion was made by Trustee Mohammed, seconded by Trustee Huynh to have staff prepare talking points based on the current categories of roles the Board would like to maintain, and roles the Board would not be interested in maintaining as they are currently on the boards and as discussed, and also for staff to prepare for the next meeting to discuss the items Trustees would like to discuss further, and the introduction sentence for section 1013 of the City Charter.

MEETING DISCLOSURES

The time limit within which to commence any lawsuit or legal challenge to any quasi-judicative decision made by the City is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision. Under Section 1094.6, any lawsuit or legal challenge to any quasi-judicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. If a person wishes to challenge the nature of the above section in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Santa Clara, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.

If a member of the public submits a speaker card for any agenda items, their name will appear in the Minutes. If no speaker card is submitted, the Minutes will reflect "Public Speaker."
