When we purchased our SBLs for Levi's Stadium, we expected to use our seats not only for 49ers games, but also for other big events like concerts, college football, and soccer. But in recent years we've grown increasingly concerned over the decline in the number of events offered to us. In the early years we received regular offers for tickets to great shows at our stadium such as Beyonce, Coldplay, the Grateful Dead, and the College Football Playoffs. I expect many of my fellow SBL members feel the same way -- we became SBL holders not only as 49ers fans, but because we wanted the opportunity to attend other world-class concerts in our stadium, rather than having to drive to places like Oakland and San Francisco, or fly down to Las Vegas or L.A.

I have seen in the media that the decline in big events is because of some battles between the 49ers and Santa Clara City Hall, and there is a new curfew that causes our stadium to miss out on big concert tours. That makes no sense. We spent \$1 billion to build a stadium and we want it to host as many big shows as possible.

It's been disappointing to see artists like the Rolling Stones, which brought impressive crowds to Santa Clara in 2019, state that "it's no longer worth the effort" to play at Levi's Stadium due to the "micromanagement" from the city. Santa Clara even lost out to San Francisco when Ed Sheeran bypassed Levi's Stadium in 2018 due to the city's 10pm curfew.

As the state reopens, we are looking forward to attending more events at OUR stadium. We paid to build it, and we want to use it. We urge the Santa Clara Stadium Authority Board to push back the curfew to help make the City a more competitive location for these events and to deliver the value that we were promised when we purchased our SBLs.

I was hopeful to see that the Stadium Authority Board is revisiting Santa Clara's 10pm curfew for Levi's Stadium events. When I initially bought my SBL for Levi's Stadium, it was because I was expecting a first-class venue that would transform Santa Clara into a local entertainment hub.

For years, Levi's Stadium was hosting high profile acts such as Coldplay, U2, Beyonce, One Direction and Luke Bryan. As and SBL holder, my family and I were excited to be able to receive offers for these shows, along with soccer and college football games. However, this ended abruptly in 2017 as Santa Clara began imposing a strict 10pm curfew for these events.

It's shocking and unprofessional to see how the city managed the Rolling Stones concert in 2019. With concert professionals stating that the city pushed for, "outlandish and frankly unsafe changes" when working with city staff. It's also worrisome that artists are specifically routing their tours away from Santa Clara because of the issues a 10pm curfew poses to artists.

We invested in this stadium with the expectation that in addition to having the 49ers playing in our own backyard, we would be able to have popular events, like concerts. What we've found is that petty political fights as detailed in the local papers have prevented Levi's Stadium from booking major concerts.

We are tired of having an empty stadium when football is not in season. Now that California has reopened, we are hopeful that Levi's Stadium can return to hosting high profile concerts. But, in order to do so Santa Clara must end the Mayor's music ban and be able to offer a competitive curfew times so that Levi's Stadium does not lose out to concerts over San Francisco, Oakland, Mountain View and Los Angeles. It's time for Santa Clara to alter the curfew to 11pm so that Levi's Stadium can sSBL holders can attend.

I'm writing regarding Santa Clara's strict curfew.
