### <u>SUBJECT</u>

Discussion About Youth Commission 2019 Community Service Scholarship Award Program

### BACKGROUND

During various City activities, the Youth Commission raises funds that are then set aside to be awarded as financial grants through the Youth Commission Community Service Scholarship Award Program (Program). Amounts vary depending on availability of funds raised each year and the number of eligible applicants. Eligibility criteria include City of Santa Clara residents, who are high school juniors and seniors that have a minimum 2.5 cumulative GPA, and have significant verifiable community service involvement. Applicants complete an application and answer supplemental questions, typically due in March, and participate in a panel interview. In the past, scoring has been based on 50 percent for application and response to questions, and 50 percent for the oral interview. Financial grant recipients are recognized at a City Council meeting in May.

### DISCUSSION

Commission will review the previous years' application process and interview questions, provide City staff with feedback, form a committee to review Program applications, and conduct interviews. Commission will also review amount of funds raised to date to help determine potential quantity and amount of scholarship funds available to be awarded. The Committee will review interview questions, facilitate applicant interviews and recommend recipients with the assistance of City staff.

### **COMMUNITY SERVICE SCHOLARSHIP**

The Youth Commission has raised funds in an effort to acknowledge their peers who are committed to community service and seek positive solutions to critical issues facing today's young people. This scholarship is primarily based on service, not necessarily on need or academic achievement. The scholarship funds can be used toward test fees, application costs, tuition payments or book expenses.

### Applicants must meet the following criteria to be eligible:

- Have significant, and verifiable, community service involvement.
- Must be a City of Santa Clara resident and a current high school Junior or Senior.
- Minimum 2.5 cumulative grade point average.
- Note: Current City of Santa Clara Youth Commissioners are not eligible for this scholarship.

### **Application Process and Packet Information:**

- Monday, March 11, 2019 by 6:00 P.M.: Deadline to submit completed application and responses to the supplemental questions to the Santa Clara Teen Center (located at 2446 Cabrillo Avenue).
- Complete the application using black or blue ink pen. You may also type into the PDF document.
- Submit a signed record of community service hours completed on organization or school letterhead.
- Submit a signed letter of recommendation to be attached to your application and essay.
- Write or type your response to each of the following supplemental questions. Responses should be kept to two, single-sided and double-spaced pages. Please include your full name on each page.
  - Supplemental Question #1: Community service is mandatory at many schools. Do you feel students benefit from this requirement? Please provide reasoning for your answer.
  - Supplemental Question #2: What impact have you had on the organization that you have focused on with your service? What impact has this service had on you?

### Selection Process:

- Saturday, March 23, 2019: Interviews will take place in person at the Santa Clara Teen Center.
- Monday, March 18, 2019: Schedule an interview by this date. Time slots will be scheduled on a first come, first serve basis.
- Each applicant will be asked the same series of questions. City of Santa Clara Youth Commissioners and City staff may facilitate the panel interview.
- The application process will be ranked in the following manner:
  - Application and Essay: 50%
    - Oral Interview: 50%
- April 2019: City staff will notify the scholarship recipient(s). Specific date TBD.
- May 2019: Expected scholarship presentation at a City of Santa Clara City Council meeting (date TBA).

Please note there are limited funds available for scholarships. Not all applicants will receive a scholarship. Recipients may not receive scholarships of an equal dollar amount.

### <u>SUBJECT</u>

Youth Commission Committee Report on Work Plan Goal-Inclusive Makerspace

### BACKGROUND

Youth Commission FY2018-19 Work Plan includes a goal to host an Inclusive Makerspace. The purpose of an Inclusive Makerspace will be to provide persons with special needs to explore STEAM (Science, Technology, Engineering, Arts, and Math) activities. An Inclusive Makerspace was initially held during the 2017-18 term at the Central Library in collaboration with the Library, the Parks & Recreation Therapeutic Recreation Services Program, and the Youth Commission. Over 200 youth with special needs and their families attended the event.

### DISCUSSION

Committee members will provide an update to meeting attendees on the 2019 event plans and logistics. The committee will discuss narrowing down the list of potential activities. Committee members have expressed a desire to continue offering an variety of activities that are accessible, while integrating new opportunities in physical activity, art, and hands-on science. Committee members have also been working with Therapeutic Recreation Services staff to determine how to best meet the needs of the targeted population (e.g. possible allergies, addressing various ability and cognitive levels).

### ENVIRONMENTAL REVIEW

The action being considered does not constitute a "project" within the meaning of the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines section 15378(b)(5) in that it is a governmental organizational or administrative activity that will not result in direct or indirect changes in the environment.
