Recreation Supervisor Herb updated the Commission on the latest developments with the Health and Wellness Fair. The Kaiser Grant Application has been submitted. Eighteen exhibitors responded that they will participate. Staff are exploring the possibility of engaging a shuttle to alleviate parking issues and to provide alternate transportation for those unable to drive.

#### REPORT TO SENIOR ADVISORY COMMISSION

#### **SUBJECT**

Senior Center Pedestrian Safety Informational Item

#### **BACKGROUND**

At the January 28, 2019 Senior Advisory Commission meeting, a community member expressed concern about pedestrian safety at the corner of Madison Street and Harrison Street. The community member observed pedestrian ramps at Madison crossing Harrison; however, there is not a painted crosswalk. The community member witnessed a vehicle that did not yield to a pedestrian crossing Harrison and assisted an elderly person across the street to the Senior Center.

#### DISCUSSION

A member of the Traffic and Engineering Division of the Public Works Department will provide information to the Commission on when and where crosswalks are installed and the criteria used to assess the need for a pedestrian crosswalk in the City.

#### **SUBJECT**

Senior Advisory Commission 2018-19 Work Plan & Goals Update

#### **BACKGROUND**

At the July 23, 2018 Senior Advisory Commission meeting, the Commission developed the 2018-19 Work Plan. The Plan was created through discussion of current trends relating to the senior population, prioritization of what the Commission has capacity to address, and local community needs.

- 1. Develop opportunities to promote Health and Wellness by
  - a. Hosting a "Be Strong, Live Long" Health & Wellness Fair May 17, 2019; and,
  - b. Educating seniors on emerging health challenges through quarterly Senior Center Newsletter articles and bi-annual educational presentations.
- 2. Increase Elder Fraud Prevention awareness by offering educational workshops three times a year.
- 3. Champion the City's World Health Organization (WHO) Age-Friendly City Initiative by
  - a. Reviewing Senior Needs Assessment findings and recommending City action as appropriate; and,
  - b. Delegating one (1) Commission member to attend the City's ADA Committee meetings; and,
  - c. Delegating one (1) Commission member to attend the City's Pedestrian Master Plan Committee meetings.

#### **DISCUSSION**

The Commission will discuss efforts and progress on goals. The sub-committee working on goal 1.b. provided an article on the use of mobile devices and apps in support of senior health and fitness for the March Senior Center Newsletter. Related to goal 3.c., the <a href="Pedestrian Master Plan Online Survey">Pedestrian Master Plan Online Survey</a> <a href="http://santaclaraca.gov/government/pedestrian-master-plan">http://santaclaraca.gov/government/pedestrian-master-plan</a> is live for public comment.
