SUBJECT

Action on a Resolution Amending in Part Resolution No. 19-8767, Setting the Number of Regular Meetings of the Board of Library Trustees and Approving the 2021 Board of Library Trustees Calendar of Meetings (Council Pillar: Enhance Community Engagement and Transparency)

BACKGROUND

City Charter Section 1003 states that each of the Boards and Commissions of the City shall hold regular meetings as required by ordinance. City Code Section 2.120.030 states that each Board or Commission shall hold regular meetings at the times and on the days indicated by resolution of the City Council and that such resolutions may be amended from time to tie by further Council resolution. Resolution 19-8767 (Attachment 1) which was adopted by the City Council on October 29, 2019 states that the Board of Library Trustees shall hold a minimum of one Board of Library Trustees meeting on the first Monday of every month (with the exception of January and July and subject to the cancellation at the discretion of the City Manager for agenda management purposes. In addition, should the first Monday of the month fall on a City holiday, the meeting would be held on the next non -holiday Monday.

DISCUSSION

At the October 6, 2020 Board of Library Trustees meeting, the Board will review a proposed resolution (Attachment 1) and meeting schedule for 2021 (Attachment 2) which includes ten (10) meetings to be held at 6:00 p.m. on the first Monday of each month with the exception of July and September. The first Monday in July is a City holiday and the first Monday in September is Labor Day. Due to COVID, it is proposed that the meetings take place via Zoom until such time that the local state of emergency is lifted. The proposed schedule will be submitted to the City Council for final approval.

SUBJECT

Election of a Chair and Vice Chair for the Board of Library Trustees (Council Pillar: Enhance Community Engagement and Transparency)

BACKGROUND

Each City Board and Commission is required to elect one of its members to serve as the presiding officer "as soon as practicable following the first day of July of every year." (City of Santa Clara Charter Section 1003). It has been the practice of the Board of Library Trustees to simultaneously elect a member to serve as Vice-Chair. The Vice Chair would serve in the absence or recusal of the Chair.

Due to the COVID-19 global pandemic and related County Health Orders suspending non-essential business, the City suspended Board and Commission meetings for the period April through August,2020. With the resumption of Board meetings, the purpose of this item is to comply with the Charter requirements.

DISCUSSION

The role of the Chair is to facilitate monthly meetings, speak on behalf of the Board at City Council meetings and work with the staff liaison on the preparation of the Board agenda. The role of the Vice Chair is to fulfill the responsibilities of the Chair when the Chair is not available.

The Board of Library Trustees may nominate any individual member to serve in each position (Chair/Vice-Chair) for the year. Individuals nominated can either accept or decline the nomination. Commissioners shall vote for one candidate to serve in each role. The Board member receiving the most votes shall assume the responsibilities for the role for which they were elected for the remainder of Fiscal Year 2020-2021 or until a vacancy occurs if sooner than the end of the fiscal year or until the next elections are held if the term is extended.
