The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision. REPORT TO COUNCIL

SUBJECT

Action on a Resolution Ratifying the Proclamation of Existence of a Local Emergency by the Director of Emergency Services [Council Pillar: Enhance Community Engagement and Transparency]

BACKGROUND

On May 31, 2020, the Director of Emergency Services (City Manager), proclaimed the existence of a local emergency under Section 2.140.060 of the Code of the City of Santa Clara, California ("SCCC") (Attachment 1) as a result of civil unrest following the killing of George Floyd in Minneapolis, Minnesota. This municipal code section empowers the Director of Emergency Services to proclaim the existence or threatened existence of a "local emergency" when the City of Santa Clara is affected or likely to be affected by a public calamity.

Any proclamation of a local emergency is subject to ratification by the City Council within seven days and allows for immunity for emergency actions; authorization of issuance of orders and regulations; activation of pre-established emergency provisions; and is a prerequisite for requesting state or federal assistance. Termination of the proclamation of local emergency when conditions warrant is required by law.

Subsequent to the proclamation of a local emergency, and based thereon, the City Manager declared a citywide curfew for the safety and welfare of all Santa Clarans (Attachment 2).

DISCUSSION

Proclaiming a local State of Emergency is a decision made with the utmost care for the safety and well-being of the residents, businesses and employees of the City of Santa Clara.

A Proclamation of Local Emergency provides the authority to:

- Provide and request mutual aid from state and other governmental agencies consistent with the provisions of local ordinances, resolutions, emergency plans, and agreements.
- Promulgate orders and regulations and exercise emergency police powers necessary to provide for protection of life and property.
- Obtain vital supplies, equipment, and such other properties found lacking and needed for the
 protection of life and property and to bind the City for the fair value thereof and, if required
 immediately, to commandeer the same for public use.
- Require emergency services of any City officer or employee and activate the use of disaster service workers who shall be entitled to all privileges, benefits, and immunities as are provided by State law for registered disaster service workers.
- Requisition necessary personnel or material of any City department or agency.

The City Manager subsequently issued an order imposing a curfew on May 31, 2020 and was based on the rapidly changing situation and legitimate threats of looting, which required immediate action by City leadership including issuing a citywide curfew.

At the time of issuance, there was already observed looting in Santa Clara and credible intelligence of Westfield Valley Fair and Santana Row shopping districts being identified as locations of potential raids. The City received these threats of looting in Santa Clara around 6:30 p.m. and at 8:07 p.m. the Santa Clara Police Department noticed the community that a curfew would be put in place. Because San José and Santa Clara were working at our shared city borders, the City of Santa Clara aligned to the City of San Jose's curfew.

Every second counts in being able to respond effectively to emergency situations such as unlawful gatherings. A citywide curfew also allows the Police Department to preserve limited resources for responding to large-scale incidents. In this case, given that Santa Clara has many shopping districts throughout the entire city, having fewer people out at night puts fewer people at risk as the City of Santa Clara public safety resources work to preserve safety at various potential locations for looting/raids.

The curfew order was lifted by the City Manager on June 2, 2020, when it was determined that the threat of larger scale looting throughout Santa Clara could be managed through regular police authority (Attachment 3). The Proclamation of Local Emergency remains in effect as the City maintains vigilance and the ability to respond quickly to any threats to public safety.

ENVIRONMENTAL REVIEW

The action being considered does not constitute a "project" within the meaning of the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines section 15378(b)(5) in that it is a governmental organizational or administrative activity that will not result in direct or indirect changes in the environment.

FISCAL IMPACT

There is no fiscal impact to the City other than administrative staff time.

A PROCLAMATION OF LOCAL EMERGENCY IN THE CITY OF SANTA CLARA, CALIFORNIA BY THE DIRECTOR OF EMERGENCY SERVICES

BE IT PROCLAIMED BY THE CITY OF SANTA CLARA AS FOLLOWS:

WHEREAS, Section 2.140.060 of "The Code of the City of Santa Clara, California" ("SCCC") empowers the Director of Emergency Services to proclaim the existence or threatened existence of a "local emergency" when the City of Santa Clara is affected or likely to be affected by a public calamity, subject to ratification by the City Council within seven days; and

WHEREAS On May 25, 2020, George Floyd tragically died in Minneapolis, Minnesota, shortly following his arrest in which an officer of the Minneapolis Police Department kneeled on his neck to detain him during the arrest, and then did not respond to Mr. Floyd's requests for help when he stated that he could not breathe; and

WHEREAS On May 29, 2020 and May 30, 2020, there were peaceful protests in the City of San Jose; however, additional civil unrest, including looting and rioting, in the downtown area of San José that resulted in arrests, injuries, fires, and significant property damage; and

WHEREAS The San José Police Department anticipates looting and rioting to continue and to expand beyond the downtown area of San José; and

WHEREAS That San Jose and Santa Clara have shared city borders where both Westfield Valley Fair and Santana Row shopping districts are located and have been identified as locations of interest for protests and raids; and

WHEREAS, the efforts required to prepare for, respond to, mitigate, and recover from the City of Santa Clara, caused by anticipated civil unrest, commencing on or about May 31, 2020, at which time the City Council was not in session.

NOW, THEREFORE, IT IS HEREBY PROCLAIMED:

That the Director of Emergency Services hereby finds that conditions of extreme peril to the

safety of persons and property do warrant and necessitate the proclamation of a local

emergency throughout the City of Santa Clara.

2. That the Director of Emergency Services of the City of Santa Clara proclaims the existence

of a local emergency within the City of Santa Clara on May 31, 2020.

3. That these conditions are, or are likely to be, beyond the control of the services, personnel,

equipment, and facilities of the City of Santa Clara

That it is therefore proclaimed and ordered that the local emergency shall be ratified by the

City Council within 7 days of this proclamation, or otherwise expire, and will be reviewed at least

every 30 days until termination is proclaimed by the City Council.

5. Effective date. This resolution shall become effective immediately.

DECLARATION OF THE DIRECTOR OF EMERGENCY SERVICES OF THE CITY OF SANTA CLARA IMPOSING A CURFEW

WHEREAS, on May 31, 2020, I proclaimed a local state of emergency within the City of Santa Clara resulting from the civil unrest following the death of George Floyd in Minneapolis, Minnesota; and

WHEREAS, pursuant to Section 2.140.060 of the "Code of the City of Santa Clara" I am empowered upon the proclamation of a local emergency to make and issue rules and regulations on matters reasonably related to the protection of life and property as affected by such emergency; and

WHEREAS, under conditions of the emergency, it is deemed necessary in the interest of public safety to restrict the use of certain public areas of the City of Santa Clara; and

WHEREAS, life and property are deemed to be in peril and speed is of the essence;

NOW, THEREFORE, BE IT RESOLVED, I, Deanna J. Santana, as Director of Emergency Services, declare the following regulation: that commencing on May 31, 2020 and on each day thereafter until lifted, a curfew be in effect starting at 8:30 p.m. and ending at 5:00 a.m. on the following day, and during which no person shall be upon the public street, avenue, alley, park, or other public place or unimproved public realty within the limits of the City of Santa Clara.

This curfew shall not apply to police officers, peace officers, firefighters, or other emergency personnel or civilians engaged in police, emergency, government work, delivery services, or utility services, nor shall it apply to authorized representatives of any news service, newspaper, or radio or television station or network, nor shall it apply to individuals seeking or providing medical care or care for family members or others, or any persons experiencing homelessness.

Any violation of this Order shall be subject to criminal and civil enforcement.

BE IT FURTHER RESOLVED that this regulation shall remain in effect until such time as it is terminated by either the Director of Emergency Services, the City Council, or the termination of the local state of emergency resulting from the civil unrest following the death of George Floyd.

DECLARATION OF THE DIRECTOR OF EMERGENCY SERVICES OF THE CITY OF SANTA CLARA LIFTING THE IMPOSITION OF CURFEW

WHEREAS, on May 31, 2020, I proclaimed a local state of emergency within the City of Santa Clara resulting from the civil unrest following the death of George Floyd in Minneapolis, Minnesota; and

WHEREAS, pursuant to Section 2.140.060 of the "Code of the City of Santa Clara" I am empowered upon the proclamation of a local emergency to make and issue rules and regulations on matters reasonably related to the protection of life and property as affected by such emergency; and

WHEREAS, under conditions of the emergency, it was deemed necessary in the interest of public safety to restrict the use of certain public areas of the City of Santa Clara; and

WHEREAS, life and property were deemed to be in peril; and

WHEREAS, on May 31, 2020, I declared a curfew to be in effect starting at 8:30 p.m. on May 31, 2020, and ending at 5:00 a.m. on the following day, and continuing from day to day until lifted, during which no person would be permitted upon the public street, avenue, alley, park, or other public place or unimproved public realty within the limits of the City of Santa Clara; and

WHEREAS, on June 2, 2020, I determined that security in the City of Santa Clara no longer requires the imposition of a City-wide curfew;

NOW, THEREFORE, BE IT RESOLVED, I, Deanna J. Santana, as Director of Emergency Services, hereby lift my May 31, 2020 curfew order. My declaration of a local state of emergency within the City of Santa Clara resulting from the civil unrest following the death of George Floyd in Minneapolis, Minnesota remains in effect.

RESOLUTION NO. ____*

A RESOLUTION OF THE CITY OF SANTA CLARA, CALIFORNIA, RATIFYING THE PROCLAMATION OF EXISTENCE OF A LOCAL EMERGENCY BY THE DIRECTOR OF EMERGENCY SERVICES

BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

WHEREAS, section 2.140.060 of "The Code of the City of Santa Clara, California" ("SCCC") empowers the Director of Emergency Services to proclaim the existence or threatened existence of a "local emergency" when the City of Santa Clara is affected or likely to be affected by a public calamity, subject to ratification by the City Council within seven days;

WHEREAS, pursuant to California Government Code Section 8680.9, a local emergency is a condition of extreme peril to persons or property proclaimed as such by the governing body of the local agency; and

WHEREAS, the purpose of a local emergency proclamation is to provide extraordinary police powers, immunity for emergency actions, authorize issuance of orders and regulations, and activate pre-established emergency provisions; and

WHEREAS, a local emergency proclamation is a prerequisite for requesting state or federal assistance; and

WHEREAS, conditions of extreme peril to the safety of persons and property have arisen within the City, based on the following, commencing on or about May 31, 2020, at which time the City Council was not in session:

1. On May 25, 2020, George Floyd tragically died in Minneapolis, Minnesota, shortly following his arrest in which an officer of the Minneapolis Police Department kneeled on his neck to detain him during the arrest, and then did not respond to Mr. Floyd's requests for help when he stated that he could not breathe.

- On May 29, 2020 and May 30, 2020, there were peaceful protests in the City of San Jose; however, additional civil unrest, including looting and rioting, in the downtown area of San José that resulted in arrests, injuries, fires, and significant property damage.
- 3. The San José Police Department anticipated looting and rioting to continue and to expand beyond the downtown area of San José.
- 4. San Jose and Santa Clara have shared city borders where both Westfield Valley Fair and Santana Row shopping districts are located which were both identified as locations of interest for protests and raids.
- 5. Some instances of looting of Santa Clara businesses did occur.
- 6. The civil unrest continues and may require swift response from the City for the protection of life and property.

WHEREAS, the Director of Emergency Services of the City of Santa Clara did proclaim the existence or threatened existence of a local emergency within the City of Santa Clara on May 31, 2020;

WHEREAS, the City Council does hereby find that the above described conditions of extreme peril did warrant and necessitate the proclamation of the existence of a local emergency in the City;

WHEREAS, California Government Code, Title 2, Division 1, Chapter 7.5 - California Disaster Assistance Act (CDAA) allows that with the Proclamation of a Local Emergency the City may seek financial assistance and may request reimbursement of the significant expenses incurred during response, if approved by the Director of the California Office of Emergency Services or Concurrence or Governor's Proclamation;

WHEREAS, the associated emergency conditions are ongoing, and the emergency should not be terminated at this time.

NOW THEREFORE, BE IT FURTHER RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

1. The Proclamation of Local Emergency, as issued by the Director of Emergency Services

on May 31, 2020, is hereby ratified and confirmed.

2. The City Council has reviewed the need for continuing the proclamation of local

emergency and finds based on substantial evidence that the public interest and necessity

require the continuance of the proclamation of local emergency related to the civil unrest

following the death of George Floyd.

3. Said local emergency shall be deemed to continue to exist until terminated by the City

Council of the City of Santa Clara.

4. The Director of Emergency Services is hereby directed to report to the City Council at

least every 30 days until termination is proclaimed by the City Council per Government Code

8630.

5. <u>Effective date</u>. This resolution shall become effective immediately.
