ADJOURNMENT

The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision. Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. If a person wishes to challenge the nature of the above section in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Santa Clara, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.

If a member of the public submits a speaker card for any agenda items, their name will appear in the Minutes. If no speaker card is submitted, the Minutes will reflect "Public Speaker."

In accordance with the requirements of Title II of the Americans with Disabilities Act of 1990 ("ADA"), the City of Santa Clara will not discriminate against qualified individuals with disabilities on the basis of disability in its services, programs, or activities, and will ensure that all existing facilities will be made accessible to the maximum extent feasible. CALL TO ORDER AND ROLL CALL

Chair Brown called the meeting to order at 7:05 p.m.

Present 7 - Member Andrew Knaack, Chair Darius Brown , Vice Chair Neil Datar, Member Dianna Zamora-Marroquin, Member Joyce Davis, Member Dorothy Ma, and Member Mark Gilley

CONSENT CALENDAR

1. 21-75 Task Force on Diversity, Equity, and Inclusion Special Meeting Minutes of February 25, 2021

A motion was made by Vice Chair Datar, seconded by Member Knaack, and unanimously carried, that the Task Force approve the minutes from the February 25, 2021 meeting.

Aye: 7 - Member Knaack, Chair Brown, Vice Chair Datar, Member Zamora-Marroquin, Member Davis, Member Ma, and Member Gilley

PUBLIC PRESENTATIONS

GENERAL BUSINESS

2. Background Presentation on Factors Relevant to Review of Police Policies

Police Chief Pat Nikolai introduced the item and handed the presentation over to Chief Assistant City Attorney Su Reuter and Assistant Chief of Police Wahid Kazem. Chief Assistant City Attorney Su Reuter provided an overview on the legal aspect of police use of force policies, implementation of the 4th Amendment, and State law pertaining to Use of Force. Assistant Chief Kazem provided an overview on the Lexipol Policy Service and Section 300 ("Use of Force") of the Santa Clara Police Department Policy Manual, as well as reported on the department's police training requirements (e.g., POST approved training, Perishable Skills Program, Communications training) and compliance to AB 392 and SB 230.

 Discussion and Possible Action on Strategies and/or Approach for Reviewing Police Use of Force Policies

The Task Force deliberated whether the review of police use force policies should be taken on by the Task Force as a whole or if the Task Force should appoint a subcommittee which would enable members to meet more frequently. Chief Assistant City Attorney Reuter suggested that the Task Force provide clarification on the subcommittee's scope of work. The Task Force clarified that scope of work for the subcommittee would be to conduct the review of police use of force policies as well as evaluate opportunities to improve community relations. A motion was made by Member Knaack, seconded by Member Zamora-Marroquin, and unanimously carried, that the Task Force establish the Policing and Community Engagement/Relations Subcommittee and appoint Vice Chair Datar, Member Davis, and Member Gilley to the subcommittee.

Discussion and Possible Action on Hosting Community Listening Sessions

The Task Force discussed continuing items to the next meeting agenda. A motion was made by Vice Chair Datar, seconded by Member Davis, and unanimously carried, that the Task Force continue Items 4 and 6 to the next meeting.

5. Discussion and Possible Action on Appointing Task Force Secretary

The Task Force thanked Member Zamora-Marroquin for serving as the Task Force's interim secretary. Member Zamora-Marroquin provided a broad overview of the secretary responsibilities. Member Ma expressed her interest in serving as the secretary. A motion was made by Member Davis, seconded by Member Gilley, and unanimously carried, that the Task Force appoint Member Ma as Secretary.

6. Discussion and Possible Action on Youth Advisory Role and Senior Advisory Role (or Any Other Advisory Role)

The Task Force voted to continue Item 6 to the next meeting agenda. The Task Force voted for the continuance of this item under Item 4.

7. Discussion on Recent Rise in Asian Hate Crimes

Member Knaack reported that he reviewed resolutions and memoranda related to Asian American and Pacific Islander hate crimes from cities and school boards and suggested that the Task Force work on possible recommendations to combat hate crime. Mayor Lisa M. Gillmor commented that she and the Police Chief were in support of this and suggested first bringing forward a resolution condemning hate crime against Asian Americans and Pacific Islanders to the full City Council for consideration. Police Chief Nikolai also expressed his support and reported on the City's hate crime statistics.

A motion was made by Vice Chair Datar, seconded by Member Davis, and unanimously carried, that the Task Force authorize Member Knaack and Member Zamora-Marroquin to work with the Mayor, Police Chief, and staff on developing recommendations to address and/or a resolution condemning hate crimes against Asian Americans and Pacific Islanders

- **Aye:** 7 Member Knaack, Chair Brown, Vice Chair Datar, Member Zamora-Marroquin, Member Davis, Member Ma, and Member Gilley
- 8. Discussion on Quarterly Update to City Council March 23, 2021

The Task Force discussed the work effort that they'd like to report to the Council at its March 23, 2021 meeting. Chair Brown suggested reporting on the adoption of the annual workplan and established subcommittees and asked for the Task Force's input. Vice Chair Datar suggested providing an update on community partnerships established. Mayor Gillmor suggested that the Task Force include the Asian American hate crime work referral in the upcoming report to Council. Member Davis inquired if the full Task Force would be able to attend the update at the Council meeting. Mayor Gillmor stated that the update would be under Special Order of Business and invited the full Task Force to attend so the new and previously appointed members could be introduced to the City Council.

9. 21-400 Review Email Communications Received

Chair Brown reviewed the email received since the last the regular meeting.

STAFF REPORT

Mayor Gillmor reported that she signed on to a support letter to address equity in vaccine allocation to the Bay Area and that the letter was sent to the California Health and Human Services Agency and the California Government Operations Agency requesting that the State urgently address disparities in California's current vaccine prioritization plan.

TASK FORCE MEMBERS REPORT

The Task Force members made general comments related to COVID-19 vaccinations.

ADJOURNMENT

The meeting was adjourned at 9:18 p.m.

SUBJECT

Presentation and Discussion on Council Policy 035 ("Naming of Facilities")

BACKGROUND

At the December 7, 2020 Governance and Ethics Committee (Committee) meeting, the Committee directed staff to refer the review of Council Policy 035 ("Naming of Facilities") (Attachment 1) to the Task Force on Diversity, Equity, and Inclusion (Task Force) for their review and input on possible amendments to the policy.

At the February 25, 2021 Task Force on Diversity, Equity, and Inclusion (Task Force) special meeting, the Task Force accepted the referral from the Committee.

DISCUSSION

Staff will provide an overview of Council Policy 035. Under the current version of the policy, naming recommendations for buildings and facilities are made based on the following criteria:

- Recognition of individuals, living or deceased, who have made outstanding contributions to the City of Santa Clara or Santa Clara community;
- Recognition of individuals, living or deceased, who have made contributions of local, state, national, or worldwide significance; or
- Geographic location, prominent environmental feature(s), or historical significance, of the area that the building/facility is located.

Staff seeks input from the Task Force on how Council Policy 035 could be updated to bring greater diversity to the naming of buildings and facilities in the City as well as to represent and connect with the City's diverse community.

ENVIRONMENTAL REVIEW

The action being considered does not constitute a "project" within the meaning of the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines section 15378(b)(5) in that it is a governmental organizational or administrative activity that will not result in direct or indirect changes in the environment.

FISCAL IMPACT

There is no fiscal impact other than staff time.

NAMING OF FACILITIES

PURPOSE

To establish the criteria and procedures for the naming of City of Santa Clara buildings and facilities.

POLICY

The City Council shall name municipal buildings/facilities in recognition of the following:

- Individuals, living or deceased, who have made outstanding contributions to the City of Santa Clara or Santa Clara community
- Individuals, living or deceased, who have made contributions of local, state, national, or worldwide significance
- Geographic location, prominent environmental feature(s), or historical significance, of the area that the building/facility is located

For the purpose of this Policy, the term "facility" shall mean property, other than streets, owned by the City of Santa Clara, portions thereof, and amenities or appurtenances thereto. Examples of a "facility" include: a City park, a meeting room within a City building, a trail, or a park bench.

The renaming of existing municipal buildings/facilities shall be discouraged and shall occur only under extraordinary circumstances, after thorough study. A proposal for the renaming of an existing building or facility shall be subject to the same procedure as set forth below for the original naming of the building or facility.

PROCEDURE

- 1. Proposals for naming of municipal buildings or facilities shall be referred to the responsible Department Head for the facility, detailing consistency with the policy criteria for naming of facilities.
- 2. Upon receipt of a naming or renaming proposal of a City building or facility, the Department Head will review if the proposed name is in accordance with at least one of the criteria as outlined in this policy:
 - An individual, living or deceased, who has made outstanding contributions to the City of Santa Clara or Santa Clara community
 - b. An individual, living or deceased, who has made contributions of local, state, national, or worldwide significance
 - Geographic location, prominent environmental feature(s), or historical significance, of the area that the building/facility is located



NAMING OF FACILITIES

If the naming or renaming proposal is reflective of at least one of the criteria, the Department Head will refer the proposal to the City Board, Commission, or Committee responsible for acting in an advisory capacity to the City Council for the building or facility at issue (e.g., a naming proposal for a park facility shall be referred by the Director of Parks and Recreation to the Parks and Recreation Commission).

If the naming or renaming proposal is not reflective of at least one of the criteria, after conferring with the City Manager's Office, the Department Head will express appreciation regarding the naming proposal to the proposer and explain the City's policy and the City's decision to decline the proposal.

- After the Department Head forwards the proposal, the City Board, Commission, or Committee, shall review all naming proposals at a publicly noticed meeting and make a recommendation to the Governance and Ethics Committee.
- 4. The Governance and Ethics Committee shall review all naming recommendations at a publicly noticed meeting and deny the recommendation or make a recommendation to the City Council for final approval.
- 5. The City Council shall consider the naming recommendation at a publicly noticed meeting and will have final approval of all naming recommendations.
 - In the event the City Council denies a naming proposal, the City Manager's Office will express appreciation regarding the naming proposal to the proposer and explain the City's policy, and the City's decision to decline the proposal.
- 6. The City Council shall have the sole discretion to decide the naming of a facility.




"Under direct supervision, performs varied, unskilled manual tasks often requiring considerable physical strength and the use of hand tools and hand power tools; loads rubbish and leaves on trucks; excavates and fills trenches and ditches; assists in the removal, trimming and spraying of trees and shrubs; prepares surfaces for paving; mixes cement; breaks up paved surfaces; helps place forms and pour concrete; lays pipes; uses such tools as shovel, rake, and jackhammer; operates trucks and heavier equipment as needed. Performs construction, maintenance and sanitation duties as required; and does related work as required."


By using the term "unskilled manual tasks", it demeans the value of said employee's worth. As far as I am aware, engineering frames for concrete pours, operating heavy equipment such as jack hammers as well as working construction and sanitation requires a tremendous amount of skill. People who end up working these positions typically need the money and may not feel they are able to advocate for better wages or working conditions because they have been labeled "unskilled manual labor". I believe the City of Santa Clara can do better to ensure all of its employees feel valued, secure, and safe in their positions regardless if they fall into the "Skilled" or "Unskilled" category. It is a small wording but its impact on individuals and society is large and damaging.

Dear Mayor Gillmor and members of the Santa Clara City Council:

We commend Mayor Gillmor and Councilmember Watanabe for sponsoring a Stop AAPI Hate event on Wednesday March 31, 2021. We have viewed the news coverage from CBS Channel 5: https://sanfrancisco.cbslocal.com/video/5449314-korean-american-santa-clara-council-member-says-he-was-denied-chance-to-speak-at-stop-asian-hate-rally/

We are shocked and outraged that Councilmember Kathy Watanabe would not allow Kevin Park, the only Korean American member of the Santa Clara City Council, to speak at that rally. With the Korean American community in shock over the hate-motived murders of six Asian American women in Georgia last month, the participation of Councilmember Kevin Park at the March 31st Stop AAPI Hate rally would have added an essential voice to the rally. Councilmember Watanabe's denial of her colleague's request to speak is a disturbing example of her lack of sensitivity to the Asian American community.

We call on Councilmember Kathy Watanabe to publicly apologize to Councilmember Kevin Park at the next Santa Clara City Council meeting.

We call on the Santa Clara City Council to pass a resolution censuring Councilmember Watanabe for her failure to allow Councilmember Kevin Park to speak at the March 31st Stop AAPI Hate rally.
