SUBJECT

Interviews and Action on one Appointment to fill one partial term ending June 30, 2023 to the Senior Advisory Commission

COUNCIL PILLAR

Enhance Community Engagement and Transparency

BACKGROUND

At the August 24, 2021 City Council meeting, the Council took action to declare a vacancy due to the resignation of Senior Advisory Commissioner Segovia creating a vacancy for a partial-term ending June 30, 2023.

On May 27, 2021 the Council conducted interviews for the Senior Advisory Commission and established an eligibility list from those interviewed which is set to expire in November, six months from the date the list was created. The Council voted to place Jim Hohenshelt and Suresh Lokiah on that list and invite them back to reinterview should a vacancy occur. Staff reached out to both applicants to inquire if there was still an interest to serve on the Commission. Both Jim Hohenshelt and Suresh Lokiah affirmatively expressed an interest to serve on the commission and to continue in proceeding with the interview process.

DISCUSSION

At the August 24, 2021 City Council meeting, Council accepted the resignation of Commissioner Segovia; and to invite back and reinterview two applicants: Jim Hohenshelt and Suresh Lokiah.

Attached are the voting guidelines (Attachment 2) for the appointment to Boards and Commissions, which outline the process for conducting interviews and casting votes by the Council for applicants.

CITY OF SANTA CLARA VOTING GUIDELINES FOR THE APPOINTMENT OF APPLICANTS TO BOARDS AND COMMISSIONS

- 1) Council is given a copy of the applications in their weekly packet to review and consider applicant qualifications.
- 2) Council interviews applicant. Interviews are held at a City Council Meeting for the Planning Commission and Civil Service Commission. Interviews are held in a less formal area of City Hall for all other Boards and Commissions.
 - A) Each applicant is given three (3) minutes for an opening statement. The applicant may respond to questions from the Council. The applicant has one (1) minute for a closing statement.
- 3) Council votes for applicants:
 - A) If there are four (4) or fewer applicants the Council will cast one vote each for their desired appointee.
 - B) If there are five (5) or more applicants, the Council will cast one vote each for their two desired appointees. Only one vote per applicant is allowed. A Councilmember may choose to vote for only one applicant but will relinquish the other vote.
- 4) The votes are tallied:
 - A) If there are four (4) or fewer applicants the Clerk will announce the winner.
 - i. If there is a tie, there will be 3 re-votes for the Council to reconsider the applicants. The Council has the opportunity to deliberate between each round of re-voting.
 - ii. If there is still a tie and there is not a full Council present, the Council will defer the decision until a full Council is present, and re-interview the top two applicants.
 - iii. If there is a full Council present, the Members will draw straws, with the person drawing the long straw abstaining from voting at the next round. The Council has the opportunity to deliberate.
 - iv. The Council votes, with the applicant receiving the highest number of votes being the winner. The City Clerk will announce the winner.
 - B) If there are five (5) or more applicants, the Clerk will announce the two applicants who received the highest number of votes. The Council then has an opportunity to deliberate regarding the remaining two applicants.

The Council will then cast one vote each for their desired appointee. The City Clerk will announce the winner.

- i. If there is a tie, there will be 3 re-votes for the Council to reconsider the applicants. The Council has the opportunity to deliberate between each round of re-voting.
- ii. If there is still a tie and there is not a full Council present, the Council will defer the decision until a full Council is present, and re-interview the top two applicants.
- iii. If there is a full Council present, the Members will draw straws, with the person drawing the long straw abstaining from voting at the next round. The Council has the opportunity to deliberate.
- iv. The Council votes, with the applicant receiving the highest number of votes being the winner. The City Clerk will announce the winner.
- 5) A Council Member makes a motion to appoint the applicant that received the highest number of votes. The Council has the opportunity to vote unanimously to appoint the applicant using the Council Chambers electronic voting equipment.

Please state reasons why you want to become a member of this Board/Commission/Committee, including what specific objectives you would be working toward as a member of this advisory board:

I want to become a member of the Historical and Landmarks Commission in order advise the City Council in matters pertaining to the marking and preservation of historical places and landmarks as well as provide advice on naming and renaming streets, museums and the establishment of new museums.

I know there is a lot to learn and I am willing to do the necessary work to become an effective commissioner. The areas of concern covered by the commission are extensive according to our historical ordinance: "...to promote the identification, protection, enhancement and perpetuation of buildings, structures and properties within the City that reflect special elements of the City's social, economical, historical, architectural, engineering, archaeological, cultural, natural, or aesthetic heritage." (Ord. 1972 § 1, 11-21-17). Though I'm not a licensed architect, I will will work with my fellow commissioners in our advisory capacity to preserve the historical landmarks and places in Santa Clara.

My further objectives on the committee, if they are found to have merit by my fellow commissioners, are:

- 1. Explore the possibility of the City creating a historic district around the Old Quad in Santa Clara with the intention of alerting property owners of the significance of their buildings as well as providing information on programs and design guidelines to preserve their properties. This will help the commission to organize their preservation advisory efforts.
- 2. Explore historic overlays for streetscapes, especially in the Old Quad. I want to preserve the characteristics of some of the streets via a historic overlay; there are few remaining intact streetscapes from the Victorian era.
- 3. Explore the restoration of the 200' impact distance to historic properties. The current 100' impact distance from historical properties in our current historic ordinance is too little.
- 4. Update our Historic Preservation and Resource Inventory for potential candidates. The City has not conducted a windshield survey of the city for over a decade, and many properties may be eligible for historic status at this time. I will advise the City to hire a licensed architect who specializes in historic preservation or an architectural historian to survey the entire city and report their findings to the commission for review. Multi-family housing complexes should be part of the survey.

Once the survey has been conducted, I would like the commission to advise the Council and City administrators to initiate conversations with the owners of those properties to see if they are interested in being formally included on the City's Historic preservation and Resource Inventory and inform those owners of further steps to preserve their properties, including steps to enter a Mills Act contract with the City.

- 5. Create re-purposing guidelines for owners of historic buildings so that they will have some initial guidance on proper re-purposing of those historic resources.
- 6. Establish a process for the commission to provide preliminary historic reviews of potentially historic properties, prior to owners engaging the services of qualified historic professionals, in order to give an estimation of the historical significance of the property. I think the preliminary review of historic applications, those initiated by owners, should be within the duties of the commissioners and formalized.

The HLC should be able to provide a simple review of historical criteria such as age of the structure and review of the integrity of the buildings and landscape. A preliminary historic review will foster more interest in preservation by property owners because it will allow preliminary review of proposals when the historic significance of a property is in doubt.

- 7. Investigate the demolition of historic resources in the past in order to improve historic evaluation and preservation processes. For example, I think new processes need to be investigated in the wake of the demolition of the historic carriage house at the Ferry-Morse mansion. I think that case justifies an exploration of how to improve the process of designation and preservation of historic resources in our city, processes up to and including the purchase and/or maintenance of the resource by the City.
- 8. Build a museum at the Ulistac Nature Area about Native American history.
- 9. Provide more interpretive signs at historic properties such as the two adobe structures in the city, and survey the city for other locations for signs such as the Santa Clara railroad depot and associated ancillary buildings.
- 10. Create a historic resources way-finding system for visitors to our city, with signs placed throughout the city. I suggest the way-finding signs start from public transit hubs, such as the Santa Clara train depot near the Old Quad.
- 11. Include the few remaining hitching posts in the city, the posts used for hitching horses in the 19th century, on the HRI and preserve them.
- 12. Provide an interpretive sign at the Franklin Mall explaining the processes (social, political, economic, and planning) that led to the demolition of the old downtown and the construction of the mall. The interpretive history should be unbiased and include the planning concerns and programs at that time in the United States, that informed the decision to construct the mall, and its local application here in Santa Clara as well as contemporary concerns with saving historic buildings and districts. I believe that period was during the 1950's through the 1960's when the planning profession was concerned with urban renewal.
- 13. Investigate the historic significance of the San Jose/Santa Clara Water Pollution Control Plant for inclusion on the HRi
- 14. Update the City's Single-Family and Duplex Residential Design Guidelines and other guidelines and ordinances to include impacts between new development and existing larger multi-family complexes, particularity the specification of compatible setbacks between and around new developments that should mirror those setbacks found in the neighborhood. Impacts between non-residential land uses and existing homes, such as between housing and strip malls and gas stations, should also be included in the update.

Additional Information

Any other information which you feel would be useful to the City Council in reviewing your application:

I successfully registered Pomeroy Green, the seventy-eight unit Mid-century modern multi-family housing complex in Santa Clara where I live, in the National Register of Historic Places. It is designated a historic district of local significance. You can find the listing at the following link (type "Pomeroy Green" in the search window in that link): https://www.nps.gov/subjects/nationalregister/database-research.htm#table.

This registration was a two year effort on my part with a little help from neighborhood residents. Completing the application required my research and documentation of the property's historic significance in three areas: community planning and development, architecture, and landscape architecture. My documentation included text, drawings, and photographs and an interview with one of the original designers, Mr. Walker of Sasaki, Walker and Associates, the landscape architects. The application is sixty-eight pages in length and a copy of the application can be found here (click on "Pomeroy Green" in the following link): https://ohp.parks.ca.gov/?page_id=24479.

While employed at the City of Santa Clara, twenty-six years as a Public Works Inspector and four as an Engineering Aide, I inspected repairs to two historic homes in the city, one being the Harris-Lass house. During my career I also inspected the construction of reinforced concrete buildings, steel buildings, and wood framed buildings in addition to inspecting civil engineering works including storm drains, sanitary sewers, underground utilities, pump stations, electrical substations, street pavements, sidewalks, and traffic signals. I also helped in the protection of clay soils, found during an excavation for a new utility, that included historic evidence of clay firing used to manufacture building components for the historic Mission Santa Clara.

During the public review process for a proposed development in my neighborhood, I became familiar with the City's Historic Preservation Ordinance, the City's Single-Family and Duplex Residential Design Guidelines, the City's Architectural Review process, the City's zoning ordinances as well as the City's General Plan. I successfully organized the neighborhood residents to lobby for a more compatible design for the proposed development.


- 1) Council is given a copy of the applications in their weekly packet to review and consider applicant qualifications.
- 2) Council interviews applicant. Interviews are held at a City Council Meeting for the Planning Commission and Civil Service Commission. Interviews are held in a less formal area of City Hall for all other Boards and Commissions.
 - A) Each applicant is given three (3) minutes for an opening statement. The applicant may respond to questions from the Council. The applicant has one (1) minute for a closing statement.
- 3) Council votes for applicants:
 - A) If there are four (4) or fewer applicants the Council will cast one vote each for their desired appointee.
 - B) If there are five (5) or more applicants, the Council will cast one vote each for their two desired appointees. Only one vote per applicant is allowed. A Councilmember may choose to vote for only one applicant but will relinquish the other vote.
- 4) The votes are tallied:
 - A) If there are four (4) or fewer applicants the Clerk will announce the winner.
 - i. If there is a tie, there will be 3 re-votes for the Council to reconsider the applicants. The Council has the opportunity to deliberate between each round of re-voting.
 - ii. If there is still a tie and there is not a full Council present, the Council will defer the decision until a full Council is present, and re-interview the top two applicants.
 - iii. If there is a full Council present, the Members will draw straws, with the person drawing the long straw abstaining from voting at the next round. The Council has the opportunity to deliberate.
 - iv. The Council votes, with the applicant receiving the highest number of votes being the winner. The City Clerk will announce the winner.
 - B) If there are five (5) or more applicants, the Clerk will announce the two applicants who received the highest number of votes. The Council then has an opportunity to deliberate regarding the remaining two applicants.

The Council will then cast one vote each for their desired appointee. The City Clerk will announce the winner.

- i. If there is a tie, there will be 3 re-votes for the Council to reconsider the applicants. The Council has the opportunity to deliberate between each round of re-voting.
- ii. If there is still a tie and there is not a full Council present, the Council will defer the decision until a full Council is present, and re-interview the top two applicants.
- iii. If there is a full Council present, the Members will draw straws, with the person drawing the long straw abstaining from voting at the next round. The Council has the opportunity to deliberate.
- iv. The Council votes, with the applicant receiving the highest number of votes being the winner. The City Clerk will announce the winner.
- 5) A Council Member makes a motion to appoint the applicant that received the highest number of votes. The Council has the opportunity to vote unanimously to appoint the applicant using the Council Chambers electronic voting equipment.

Subject: Conflicts Review – Historical and Landmarks Commission Applicants

Background

The City Attorney's Office has been asked to review applications to City Boards and Commissions regarding potential conflicts of interest. The applications generally do not provide complete information regarding potential conflicts; however, they do occasionally disclose potential conflicts of interest or incompatible offices. The purpose of this memorandum is to highlight areas of potential conflict that are disclosed by the application. In order to analyze potential conflicts, it is necessary to consider the duties of the particular commission for which the applicant is seeking appointment. This review is limited to the information provided on the applications and is not intended to be comprehensive investigation of potential conflicts involving the applicants.

Commission Duties

Pursuant to the City Charter and the City Code, the Historical and Landmarks Commission is responsible for acting in an advisory capacity to the City Council in all matters pertaining to historical landmarks, names and renaming of street, museums and the establishment thereof in the City, and the marking and preservation of historical landmarks and places.

Legal Conflicts that May Preclude Vote or Participation

Certain positions may preclude a commissioner from participating in a commission discussion or from voting if a matter involving the entity comes before the commission. While this list is not complete, these types of conflicts generally fall within one or more of the following situations:

- An applicant has an interest in property the value of which could be affected by a decision coming before the Commission
- An application shows entities that are "sources of income" to a potential commissioner within the
 12 months preceding the start of the commission term, as defined under the Political Reform Act,
- An applicant is an officer or employee of an entity that could be involved in a matter coming before the commission, or
- An applicant engages in a profession serving the local market that is likely to realize financial benefits or detriments, distinguishable from the public generally, that would result from the work performed by the Commission

Appearance of Bias

There may be facts which would not amount to a legal conflict of interest requiring a commissioner to recuse him- or herself from a commission vote or discussion, however the relationship could create an

appearance of bias on the part of the commissioner. The Code of Ethics and Values requires that Commissioners "make impartial decisions, free of . . . financial and other personal interests that impair [one's] independence of judgment or action." Accordingly, a situation may arise that may require a commissioner to recuse him- or herself if the facts could reasonably lead one to conclude that the applicant would be biased for or against an entity or entities.

Review Of Applicants

Set forth below are the applicants and any apparent legal conflicts of interest and/or appearance of bias related to entities that are likely to come before the commission in some manner, as identified on the applications.

James E. Craft

- The Applicant is an engineer with Lockheed Martin. No other sources of income were disclosed.
- The application discloses neither incompatible offices nor apparent conflicts of interest.

• Lisa Goulet-Mah

- The Applicant is a realtor with Coldwell Banker. No other sources of income were disclosed.
- The application discloses neither incompatible offices nor apparent conflicts of interest.

Ken Kratz

- The Applicant is a retired public works inspector for the City of Santa Clara and former member of the Bicycle and Pedestrian Advisory Committee.
- o The application discloses neither incompatible offices nor apparent conflicts of interest.

Ed Stocks

- o The Applicant did not list an occupation and no sources of income were disclosed.
- Based on the information provided, whether an incompatible office or conflict of interest exists is unclear.

Alan Weissberger

- The Applicant is a content manager with IEEE. It appears that IEEE is a professional association for electronic and electrical engineers. No other sources of income were disclosed.
- The application discloses neither incompatible offices nor apparent conflicts of interest.

Cecily Cox

- The Applicant is a teacher with the Diocese of San Jose. No other sources of income were disclosed.
- The application discloses neither incompatible offices nor apparent conflicts of interest.

Conclusion

The City Council may wish to consider the above comments in making its appointments to the Commission.
