City Clerk Haggag provided a presentation on Why Redistricting Matters. **Demographer Jeanne Gobalet, Ph.D** provided a PowerPoint on Population Balancing.

Demographers Jeanne Gobalet, Ph.D and Shelley Lapkoff, Ph.D provided a PowerPoint presentation on Tutorial of Drawing of Plans using Pieces Tool.

The meeting went into recess at 7:15 p.m. and reconvened at 7:25 p.m.

GIS Specialist Robin Merrill provided an overview of Maptitude Online Redistricting (MORE) Tool.

Assistant Director of Community Development Reena Brilliot provided information that the cost to purchase the Maptitude Online Redistricting Tool would be \$35,000.

Commissioners inquired on the cost of the tool, how many user accounts could be set up, if there would be a trial period, how many jurisdictions use the MORE mapping tool, and other clarifying questions.
