Please read my letter during Public Presentation at the December 7, 2021 Council Meeting

Dear Mayor and Council Members,

It is with frustration and anger that I compose another email. The 49er Five, Jain, Chahal, Park, Hardy and Becker voted to change the curfew at Levi Stadium from 10PM to 11PM on Thursday, Friday, Saturday and Sunday. The 49ers agreed to a 10PM weekday curfew when approval was adopted in 2010. Why wasn't Public Presentation allowed before the vote? Council member Becker said he doesn't hear complaints about stadium noise or other problems. Mr. Becker's district is on the other side of Santa Clara. Why don't the 49er Five come to North Santa Clara and ask us what we think. Even our own District 2 representative doesn't listen to us.

I want Council Members Hardy, Park and Chahal to answer why they were getting a tour of Levi Stadium by Jim Mercurio the day before the curfew vote? I also want to know who paid for the Field Access tickets for Council members Hardy, Chahal and Park to be on the field during the National Anthem of that game? Were they gifts from Jed York?

These same Council members, plus Jain and Becker voted not to extend funding for the police. Who is going to monitor the late problems at Levi? The Police are already short staffed. Crime is on the increase. We see a local shoe store, at Scott and El Camino, burglarized twice in a week.

I've lived in Santa Clara since 1974. In that time there have been a few council members that I felt lacked integrity and professionalism to represent Santa Clara. Never have I seen five members of the same council, (Jain, Hardy, Becker, Park and Chahal) who all seem to lack the integrity and commitment to the people that is necessary. These council members are representing the 49ers. They voted to fire City Attorney Brian Doyle because Mr. Doyle was attempting to make the 49ers live up to their responsibilities and

contracts. Who will these 49er Five go after next?

I hope these pro 49er Council Members realize that we the voters are watching and some of you will want to run for re-election or even mayor. Many of us will be asking tough questions of your actions and decisions. Even the 49er money may not be able to help you.

Also, I WANT MY EMAIL READ AT THE COUNCIL MEETING DURING PUBLIC PRESENTATION on Tuesday.

Although, the Stadium was built around mostly commercial and business offices, there are thousands of people that live around that Stadium and your decisions directly affect them!

I am completely opposed to these recent decisions:

- \* Weekday curfew changed from 10 PM to 11 PM (Sunday through Thursday) and also allows for pyrotechnics until 11 PM. What about people with PTSD, children's sleep, residents sleep, pets, etc.? These always sound like bombs or gunshots! It's truly alarming! It's already bad when Great America does it for 4th of July!
- \* Weekday curfew changed without public outreach nor transparency. Living in North San Jose, I realize we don't get a say because we are not part of your district, but we are DIRECTLY affected!
- \* Public safety cuts are going to be impacted. The Stadium brings in so many people that love to party and that causes a lot of issues for all the neighborhoods, especially mine in North San Jose (Renaissance Drive), where many people park to avoid the high cost of parking.
- \* Neighborhoods are going to be inconvenienced and an even bigger nuisance created. Parking is already a problem on public streets especially Lick Mill Blvd. from Hope to Montague and neighborhoods near Fairway Glen and Renaissance Drive & Tasman.
- \* Promises have been broken by 49ers. They will continue to pick profits over safety, because they can get away with it!
- \* The 49ers agreed to the 10 PM weekday curfew when conditions of approval were adopted in 2010. See, with time, how they are now changing this?
- \* The 49ers management have been terrible managers of stadium. They don't care about the neighborhoods that surround the stadium as long as they make money! It's always about money!
- \* Stadium management have booked money losing events. Many cities have booked successful weekend events. Santa Clara and San Jose are two of those cities.
- \* How come the maker of the motion to change the curfew, Anthony Becker, would not consider changing the curfew for ALL of the districts when asked by Kathy Watanabe? Why is only District 1 going to be impacted by this change? District 4 is affected too!

Dear Sir/Madam,

I am requesting you to please read the following message in the Santa Clara council meeting on 12/7/21. Although I am a resident of North San Jose, we are deeply impacted by your actions on Levi's stadium.

My name is Sri and I have been a resident of California Impressions in North San Jose since 2007. I **was** a big fan of 49ers. As a 49er fan, although our community didn't get the opportunity to vote for Measure J in 2010, I was cautiously optimistic about a 49ers stadium close to home. The opportunity to walk to football games and the development prospects of the neighborhood were attractive. The concern for the safety of my family was in the back of my mind. My concern was about the intoxicated, unruly and inconsiderate fans.

As a 49er fan, I enjoyed touring Levi's stadium with my daughter's elementary school and few football games. It is not very hard to overlook the vast difference between Santa Clara's District 1 and San Jose's District 4's governance during the game. I swept the contrast underneath the rug. Illegal and unsafe parking in No Parking zones by the event attendees is a temporary inconvenience. I picked up the trash left behind by 49er fans and felt that "few bad apples" don't represent the larger population.

It was a difficult pill to swallow when I and my kids noticed a "Mexico vs Chile" soccer attendee urinating on our neighborhood wall after the game. I brushed it aside as a rare occurrence.

It is however, very difficult to accept the disturbance from stadium event attendees. It is common for the visitors to the stadium to talk loudly as they pass through our neighborhood. My high school going son becomes anxious and has a difficultly going to bed. The helicopter hovering over the area during late night events aggravates the sound pollution problem in our neighborhood. To say the least, this is causing a lot of emotional strain on our entire family. I am worried that these late night events will not only affect my family's health but also my son's studies.

To make matters worse, the Santa Clara city council recently decided to vote on curfew change without factoring any of the citizens who live near the stadium. This lack of transparency is appalling and disgraceful. The 49ers administration risks not only losing fans but also business. The 49ers stadium management has already broken previous promises. The curfew conditions approved in 2010 were violated few times during late night concerts. Why is Anthony Becker changing curfew times only for Santa Clara District 1 and San Jose District 4? Why not change curfew conditions for all districts?

Please reconsider the curfew relaxation for District 1 in Santa Clara and District 4 in San Jose. I will suggest conducting a town hall and factor the local residents opinions.

Honorable Mayor and City Council:

I request that the contents of my email message below be read into the minutes of the Tuesday, December 7, 2021 City Council Meeting.

Since the last City Council elections, several developments have ensued that concern me greatly, as a resident and homeowner in District 1 – in the neighborhood known as “49ers backyard”. First, the potential existence of a conflict of interest – real or perceived – that is created by the continued participation by members of the City Council in closed-door meetings with 49ers management. The lack of detailed meeting records or any public divulgence of the content of these meetings is an egregious departure from the Brown Act and the principles of good government. To further complicate matters, three members of the Council were seen getting a tour of the stadium prior to the Chargers game and seen on the field itself during the national anthem. The fact that these Council members appeared to be receiving favored treatment by the 49ers THE DAY BEFORE an important vote was taken regarding the curfew is at the very least terrible optics, and at worst, indicative of a City Council in thrall to a corporate entity that often seems to act in ways that are antithetical to interests of me and my fellow residents of District 1.

I am not going to directly accuse Councilmembers Suds, Park, Chahal, and Hardy of unethical and corrupt behavior, but so far, their actions are problematic. I strongly urge these members, and the City Council as a whole, to demonstrate - through both words and actions - that they are representing the interests of the City of Santa Clara and its citizens rather than the interests of the Forty Niners Football Company LLC. The fact that the curfew was amended ONLY for District 1 indicates to me that it was done solely for the benefit of the 49ers to the detriment of me and my neighbors.
