WHEREAS, on September 29, 2020, the City Council set the Council and Authorities (including

twice each month, and that all regular meetings be set by ordinance or resolution;

WHEREAS, based on two vacancies and a pending resignation in the City Clerk's Office, staff is

revising the council calendar dates to meet the Charter requirement of two meetings per month by

combining the Council and Authorities and Stadium Authority meetings as there is a lack of staff

capacity and resources; and,

WHEREAS, to ensure compliance with Charter Sec. 707, it is required that the Council implement the schedule change for the months of September and October by resolution.

NOW THEREFORE, BE IT FURTHER RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

1. That the Council revise the Council and Authorities (including Stadium Authority) regular meeting dates for the 2021 calendar year as follows:

A. Cancelation of the September 14, 2021 Council and Authorities regular meeting and September 21, 2021 Stadium Authority Meeting and set September 7, 2021 as a Joint Council and Authorities and Stadium Authority regular meeting. If a Special Council meeting is needed both September 14 and 21 would be available to allow for no further delay.
