Subject: Concern regarding 3066 Harding Ave Project

Dear City of Santa Clara Leaders,

We are the residents at 3073 Harding Ave, and we have received notice from the city regarding a development review hearing for the house located at 3066 Harding Ave on Wednesday, January 12, 2022 (File NO. PLN21-15378). As a neighbor of this household, we have some concerns to bring to your attention before the planning meeting.

The project is for a two-story house with a balcony and big windows which will have significant impacts on this street and its neighbors. Harding Ave consists of one-story Eichler houses. This renovation will dramatically change the street view and the character of the neighborhood. These changes are not favored by the most residents on this street.

1. Balcony and French door.

The proposed balcony and the French doors are the top concern. There are also two other windows facing the street: a total of three on the North side where our house is located.

The proposed balcony and French doors will be on 3066 Harding Ave's garage roof. Our living room and front yard are facing towards their garage roof with a wide range of angles. Our house has this kind of French windows in our living room which makes our room very bright and enjoyable. My young kids really like to play in our front yard, and watch TV in our living room. We adults also enjoy the relaxed time there. I tried a few positions from different angles in my living room and I can see 3066 Harding Ave's garage roof easily and clearly all the time. If I can see them, then they can see us too. The situation is much worse when the outside is dark and our living room lights on. We will not have privacy in our living room any more with the proposed balcony and French doors. Same thing is also true for our front yard because I can see their garage roof from all different positions when I am standing in our front yard. Our front yard will lose privacy too. So, we strongly ask for the removal of the balcony and French doors.

2. Two windows on the north side.

There are two other windows facing our house. They also make us very uncomfortable. We suggest they either make some changes, such as make windows higher and smaller, or windows could be facing inwards instead of facing us straight, or learn from another neighbor's plan which is located at 3054 Harding Ave and will have only one story.

I attached a picture which is the view when I am standing on my garage roof to see 3066's property. There are similar views if they are on their balcony or behind their french door which will be located on their garage roof.

However I am neither a professional photographer nor a lawyer and I just want to show what's the future view looks like. If there is any aspect that involves the privacy, please help not to disclose the pictures to the public. Thank you.

I also attached a PDF which has a list of neighbors' signatures gathered, along with a picture showing their relative locations to the project at the end of this email. The number of signatures shows most of the neighbors are really concerned about this project. The impact on our neighborhood is huge. Some of these neighbors are seniors. They are not familiar with email or zoom. The signature is a way for them to express their concern.

We hope the design could respect the neighbor's privacy. Another remodel planned at 3054 Harding Ave is more appropriate and matches other structures on Harding Ave. We suggest they may learn from 3054 which will be easy to approve, and we ask that the current design for 3066 Harding Ave not be approved so as to preserve our rights to privacy within our home and fenced yard.
