## A RESOLUTION OF THE CITY OF SANTA CLARA, CALIFORNIA RECITING THE FACTS OF THE CONSOLIDATED MUNICIPAL SPECIAL ELECTION HELD IN THE CITY OF SANTA CLARA ON June 7, 2022, WITH THE STATEWIDE DIRECT PRIMARY ELECTION DECLARING THE RESULTS OF THE ELECTION AND SUCH OTHER MATTERS AS PROVIDED BY LAW

## BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

WHEREAS, a Consolidated Municipal Special Election was held and conducted in the City of Santa Clara, on Tuesday, June 7, 2022, as required by law;

WHEREAS, notice of the election was given in time, form and manner as provided by law; that

voting precincts were properly established; that election officers were appointed and that in all

respects the election was held and conducted and the votes were cast, received and canvassed

and the returns made and declared in time, form and manner as required by the provisions of

the Elections Code of the State of California for holding of elections in charter cities; and

WHEREAS, pursuant to Resolution No. (a resolution calling for a consolidated special municipal

election to be held on June 7, 2022 with the Statewide Direct Primary election) adopted on

February 22, 2022 and July 7, 2022, the County Registrar of Voters canvassed the returns of the

election and has certified to this City Council, the results are received, attached and made part

of hereof as Exhibit A and B.

# NOW THEREFORE, BE IT FURTHER RESOLVED BY THE CITY OF SANTA CLARA AS

The City of Santa Clara, California, hereby declares that it would have passed this resolution and each section, subsection, sentence, clause phrase, and word thereof, irrespective of the fact that any one or more section(s), subsection(s), sentence(s), clause(s), phrase(s), or word(s) be declared invalid.

5. <u>Effective date</u>. This resolution shall become effective immediately.
