Transparency and accountability are often key commitments made in campaigns for public office. They are important to ensure to the public we have elected officials whose actions are that of honesty, integrity, and fairness, to name a few values. In addition to those, the public expects elected officials to disclose conflicts of interest, update their public calendars promptly, and make timely financial disclosures, among other required provisions. Corrections, when needed, should be made promptly. Failure to do so erodes the public's trust. When transparency and accountability are found lacking in a city council, it tarnishes not only the council's reputation but also degrades the image of the city as a whole.

At the June 7 meeting, a petition, Item 22-780, was presented by Mr. Brian Doyle. That petition was in regards to a sitting councilmember, Mr. Park, and Mr. Park's reportedly inconsistent statements submitted in public filings as required for public office campaigns. Mr. Doyle's petition was heard, debated and denied, not so much on the merits of the petition itself, but due to Mr. Doyle's ongoing litigation with the City. It was recommended that the petition be re-submitted once legal issues between Mr. Doyle and the City had been resolved – whenever that might be.

I was very dismayed. What kind of City Council do we have here? Do we have a City Council who are transparent and accountable? Is this vote to deny the petition, not based on the petition's merits, a symptom of a larger problem? Does this Council violate the public trust and play favorites in their dealings with other entities as well?

Mr. Park has had plenty of time to resolve the issues raised by Mr. Doyle and yet, these issues persist. The public does not need half-hearted, condescending apologies wrapped in arrogance talked down to the public as one might to a child. The public demands transparency and accountability.

So what can be done? Tonight, I am submitting to the City Clerk's office my own petition to have the same matter as presented by Mr. Doyle placed on a future Council meeting agenda. My petition is remarkably similar to that of Mr. Doyle's. I have no legal entanglements with the City, so there is no need to wait until any legal proceedings are resolved. Should Mr. Park wish to demonstrate his commitment to transparency and accountability to the public in this forum, I will withdraw my petition.

Thank you for your attention to this important matter.

WRITTEN PETITION REGARDING KEVIN PARK

There are some serious inconsistencies in official filings by Councilmember Kevin Park that indicate at best an unacceptable level of deceit and at worst perjury.

On August 4, 2020 Kevin Park filed a Statement of Economic Interest (Form 700) in conjunction with his candidacy on which he declared that he had no reportable interests of any kind. (Attachment 1) He signed his name under the statement: "I certify under penalty of perjury under the laws of the State of California that the foregoing is true and correct."

The August 6, 2020 filing clearly states that Mr. Park was employed by "TCS" from February 2017 through at least the date of filing. Yet Mr. Park never declared any income from TCS on his August 6 Statement of Financial Interest as he was required to do.

On December 22, 2020 Mr. Park filed his "Assuming Office" Statement of Financial Interest (Form 700). (Attachment 3) He again declared that he had no reportable interests of any kind. He signed his name under that statement: "I certify under penalty of perjury under the laws of the State of California that the foregoing is true and correct."

Mr. Park was sworn in as a Santa Clara City Councilmember on December 8, 2020. Thus, he was required to report his income from the prior 12 month period beginning December 7, 2020, including any income received from TCS. Instead, he stated under penalty of perjury that he had no reportable financial interests.

In Mr. Park's latest Form 700 filed on April 1, 2022 (Attachment 4) he states under penalty of perjury that he received over \$100,000 in income from Tata America for the period of January 1, 2021 through December 31, 2021:

The foregoing public records raise the following questions:

- Councilmember Park was required to have declared his sources of income from the twelve month periods beginning in August 5, 2019 and December 7, 2019, yet he states under penalty of perjury on two separate occasions that he has none.
- At the same time, he states in his Official Filing Form entitled Ballot Designation Worksheet that he worked at TCS from February 2017 at least through August 6, 2020. TCS stands for Tata Consulting Services.
- Then in his April 1, 2022 Form 700 he states that he earned more than \$100,000 from Tata America during calendar year 2021.
- Did Mr. Park really stop earning any income from TCS after August 5, 2019 and then start earning income from Tata America sometime in 2021?
- If so, how could be afford to live in Santa Clara?
- Did Mr. Park falsely state on his Official Filing Form that he was still employed as a Manager by TCS on August 4, 2020?

 Or did Mr. Park really have income in the period from August 2019 through December 2020, and he committed perjury when he filed his two Form 700's in 2020?

I hereby request the City Council to place an item on a future agenda to allow Mr. Park to answer these questions. Please do not vote to cover up Mr. Park's apparent dishonesty about his sources of income.
