Commissioners reported the following updates to the Cultural Commission Work Plan Goals for FY 2022/23.

GOAL #1: Host and enhance multicultural events to encourage and acquaint Santa Clara residents with cultural diversity.

Summer Concerts-

Commissioner Samara mentioned the last concert of the series is Friday, Oct. 7, Latin Heat in Central Park. **Chair Diaz** stated she will be attending the concert and asked which commissioners are planning to attend:

Commissioners von Huene, Sundaram, Samara, and McNamara indicated they will be attending. **Commissioner Marinaro** did not confirm his attendance.

Commissioner von Huene mentioned there was feedback to host two (2) concerts on the Northside. First concert will be June 23, 2023. There is an extra expense for the stage at Live Oak Park.

Concert in the Park and Street Dance committee will be **Chair Diaz**, and **Commissioners Sundaram and Samara**.

Budget-Mid Year summer review possibly at the next meeting. Sponsorship money will go directly to the Cultural Commission budget.

Commissioner Samara requested the same Sponsorship Information Packets can be used for the 2023 concerts and Street Dance. Packets will be updated with the new dates.

GOAL #2: Develop and encourage interactive, art opportunities to provide temporary, performing, cultural, and public art in the City.

Public Art-

No update.

Utility Box Art-

Chair Diaz reported that all winners were notified. One of the winners

wanted to wrap the Utility Box and not paint it, so an alternate artist was selected. Agreements have been sent out. One artist has completed the insurance requirements and is waiting for the agreement to be executed before painting can begin.

Halloween Home Decorating Contest-

Chair Diaz reported that the Contest was formerly announced and posted on Facebook. Submissions are due Oct. 26. One winner per District and one overall winner. 7 winners total. Judges: **Commissioners Sundaram, von Huene and McNamara**. The Committee will vote and then meet to determine the winners. Signs will be delivered on the 28th.

Commissioners Samara and Marinaro are available to help deliver signs. Same committee will do the Holiday Home Decorating, with the exception of **Commissioner Marinaro** filling in for **Commissioner Sundaram**, as he will not be available.

Map-

Chair Diaz will add to the map as information is available.

GOAL #3: Raise the visibility of commemorative months.

Commissioner Samara will present next meeting. **Chair Diaz** will assist.

Commissioner von Huene posted updated information on Facebook and **Tyler Frietas** Recreation Coordinator, posted the information on Instagram.

GOAL #4: Enhance communication and media strategy to increase community awareness of the Cultural Commission.

Recreation Manager Castro reported the following: The Halloween Home Decorating Contest kicked off. The deadline for submissions is Oct. 26. Submissions are online only. Friday Oct. 7 is the last Concert of the series, with Latin Heat in Central Park. They partnered with a local nonprofit organization, San Jose Puerto Rican Civic Club that will have a table and raise funds to help the victims of the hurricane in Puerto Rico. There is a survey for East Neighborhood Park at Related Santa Clara requesting the public's feedback. The final meeting of the HomelessTask Force is Oct 27. Children's SooktaClara Halloween Party will take place on Sat. Oct. 29 from 12-3 p.m. in Central Park.

Commissioner Marinaro reported he has been traveling for work events. He also attended Diego Rivera's America Exhibit in SF. He highly recommends attending. His murals are displayed in video. Phenomenal portraiture and fantastic exhibit.

MEETING DISCLOSURES

The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision. Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. If a person wishes to challenge the nature of the above section in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Santa Clara, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.

If a member of the public submits a speaker card for any agenda items, their name will appear in the Minutes. If no speaker card is submitted, the Minutes will reflect "Public Speaker."

In accordance with the requirements of Title II of the Americans with Disabilities Act of 1990 ("ADA"), the City of Santa Clara will not discriminate against qualified individuals with disabilities on the basis of disability in its services, programs, or activities, and will ensure that all existing facilities will be made accessible to the maximum extent feasible.
