Chapter 6 - Strategic Planning of, "The Successful Library Trustee Handbook" was reviewed and discussed. There is funding available this FY to obtain a consultant. Due to the Brown Act, Theresa Porter can only consult with 2 Trustees on hiring a consultant. Once a consultant is hired they will work with staff and the Board representatives to review data sets and plan for the future. It has been almost 10 years since the last Strategic Plan. There will be much needed guidance with implementation from the consultant.

**STAFF REPORT**[22-1236](#)      City Librarian Report on Library Programs and Activities.

**Recommendation:** Note and file monthly update on Library activities.

**City Librarian, Wong** and **Assistant City Librarian, Dolly Goyal** shared the proposed operating hours. The hours will expand from 64 hours total to 86 hours total across the three branches. We will retain the same level of staffing we have now. We could operate on the new schedule without any as-needed employees, if necessary. There may be programming minimizations in order to allow us to accommodate more open hours. The City Manager's Office and City Council is reviewing the proposed schedule. These extended hours will accommodate some of the needs of the community. The new schedule will be implemented on the last day in October. The garage will be open during Library hours. Café Sarah will not be reopened until contracts have been negotiated with the City. Staff is considering holding Comic Con bi-annually rather than annually due to the cost and time of preparation of the program.

**City Librarian, Wong** reviewed the STAR Library ranking process. The Santa Clara City Library falls in the \$10-\$29.9 million dollar expenditure range. A STAR Library is composed of a combination of factors including how much money is in the budget, population size, and a number of factors, the largest being circulation by capita. Per person/capita we have a lot of use. Our entire service area would be included in the data set, not necessarily only residents. The ranking is based on the State Library Report information. The data set for 2021 is compiled using the 2019 numbers. The figures are always two years in arrears. Right now staff is completing the 2021 report which will not be reviewed until 2023. **Technical Services Program Coordinator, Yu-Lan Chou** is heading the data committee that is ensuring data is collected and complete.

Staff will be sharing every Grant we receive with the Board going forward. As we get closer to the Strategic Plan we will consult with the Board about any stakeholders so no one is forgotten. Comic Con is coming up October 22, 2022.

**TRUSTEES REPORT**

**Vice Chair Hintermeister** would like to see more statistics. The Library budget is 1% to 4% of the City budget depending on if your looking at the full budget or just the general fund. The Library has taken a disproportionate hit to hours. In terms of expenditure, the City of Santa Clara spends about 60% of what the County spends. **Vice Chair Hintermister** reiterated his desire for a subcommittee for on boarding new trustees to be formed.

**MEETING DISCLOSURES**

The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision. Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. If a person wishes to challenge the nature of the above section in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Santa Clara, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.
