The amendments to the previous language for Section 600 and the addition of a Section 601 just make the measure more complicated than it needs to be. Why not just do the equivalent of what they do in the state legislature as "double-jointing"? With this, there would be a version of Section 600 as was approved in January, and an alternate version of Section 600 that incorporates the changes necessary to make the City Clerk appointed (i.e., deleting "City Clerk" from the list of elected officials where it appears), with the provision that the alternate version would go into effect only if Measure 2 also passes.

The amendments to Section 703 (in Exhibit A but not referenced in the resolution language) do not belong in this ballot measure, as they have nothing to do with the way in which the city's elective officers are elected. They should be part of Measure 2, not of Measure 1, because the only purpose for making the change is to no longer have a list of elective offices that includes that of the City Clerk.

If the proposed language for this ballot measure is submitted to the voters and approved, this would result in Santa Clara having a charter that still includes language calling for the City Clerk to be elected (in different places depending on whether Measure 1 as proposed is also approved), but an additional section calling for such references to be deleted.

Instead, the measure should propose modifications to the current sections 600 and 703 to remove the references to the City Clerk being an elected office, with an alternate version of Section 600 that both does that and incorporates the changes to how elected officers are elected that are the purpose of Measure 1, with the provision that the alternate version would go into effect only if Measure 1 also passes.

The change to city council districts has negatively impacted every city that has adopted it, by diverting city funds intended to maintain the infrastructure into race-influenced spending.

San Jose is a prime example: their candidates no longer represent the entire city. In many if not most cases, candidates in San Jose elections represent their race first, while their city has a lower priority.

Changing to district-based elections would make a candidate's race a primary consideration, above what they would contribute to the entire city, in effect making the city a racist entity—as it has happened in San Jose. On behalf of the nonprofit organization FairVote, I am expressing our concerns about the amended measure wording.

We would greatly prefer if the city would use the following wording instead, which is shorter and which we think is easier for voters to understand.

Preferred wording:

BY-DISTRICT COUNCIL ELECTIONS & VOTING METHOD. Shall the City Charter be amended to change the method by which voters elect city officers by: creating two districts starting in 2018 to be represented by three Council Members each; and, starting in 2020, using ranked choice vote to determine winners of elections of all city officers, including Mayor?

Our concern with the proposed Draft Ballot Measure 1 wording is that voters may infer that the omission of the mention of City Clerk while all other positions are mentioned means that this question impacts whether or not the City Clerk remains an elected position or not. We don't believe it's necessary to mention "Single Transferable Vote" in the wording since it's all spelled out in the measure text. We hope that the city council will direct staff to use our preferred wording instead. Thanks for your attention to this.
