This letter is structured responding to the thoughtful areas Council and audience members suggested should be addressed by any prospective applicant in the Council's May 22, 2018 meeting. I trust the following will assist in your, and the public's, important vetting process.

1. Previous Candidacy for City Council - I have run for a seat on City Council on four occasions. I was successful on none. I sought appointment to Council in 2011 and 2016 when vacancies arose. I was not appointed in either.

In total, I received 35,811 votes of 110,551 total votes cast for the seats I competed in those four elections. My best estimate is that I visited over 25,000 Santa Clara residences to solicit votes. I appeared in approximately twenty candidate forums, sought (and sometimes/sometimes not receiving) endorsements from traditional stakeholders and media. **Full disclosure:** I was endorsed by the Mercury News in each of the three campaigns in 2012, 2014, & 2016.

2. Campaign Contributions - In my four races, I raised a total of estimated \$140,634.02. Approximately 80% of that total came from individual City of Santa Clara residents and 20% received from family and friends outside the City.

3. Agenda - It would be hubris to promise that my selection to Council is, in and of itself, transformative. It is not. With five months remaining on the term, I will do my best. I need to learn, study, ask. **Humility**, an opportunity to heal and apply my judgment and common sense as best I can be my operating principle for the term remaining.

4. Special Interests - No developer/49er interest/chamber of commerce nor any other group has ever contributed nor ever been solicited to make any contribution to any of my campaigns.

5. Controversy - In my 2016 Council race, media reported that a certain "Blu-Pac" supported me, and two other candidates' races. As I publicly stated on every occasion, I had not then, nor now, any knowledge of any do such support by this nor any other "dark money."

6. Will You Run in November? - I've run for Council on four previous occasions, applied during vacancies twice. All unsuccessfully. Anyone aware of those facts may reasonably conclude, "Yeah, he will." Tomorrow is not guaranteed as we know. If appointed is this something I wish to pursue over family and kids time? Who knows? I cannot answer this query now.

7. Performance: I will leave no stone unturned if appointed.
