

Survey Methodology

- Live telephone survey of likely Nov. 2018 voters in the City of Santa Clara
- Conducted June 14-21, 2018
- 400 total interviews; margin of error ± 4.9 percentage points
- Interviews conducted by trained, professional interviewers and included both landlines and cell phones
- Interviews were conducted in English, Spanish, Chinese, and Vietnamese
- Two focus groups with voters were conducted on June 28, 2018




Issue Environment



Nearly two-thirds of respondents are optimistic about the direction of Santa Clara.





Revenue Measures






Unfortunately, support for a bond measure is below the two-thirds threshold needed to pass. The below Ballot Question is AB 195-compliant and was reviewed and approved by the City Attorney.

City of Santa Clara Parks/Libraries/Public Safety Improvement Measure

\$100,000 of assessed valuation, generating approximately \$13,700,000 annually; and issue up to \$200,000,000 in bonds, at legal upgrades to fire stations; upgrade storm/flood infrastructure; shall the City of Santa Clara collect taxes approximating \$25 per To upgrade local park facilities/trails; expand libraries; build an energy efficient community recreation/swim center; fund safety rates, to be repaid over 30 years; requiring independent oversight, published audits, and all funds benefiting Santa Clara?







Vote Progression: Bond Measure




The potential bond measure never reaches the necessary 2/3's requirement threshold throughout the survey.

Focus Group Findings

Focus Groups: Commercial Cannabis Tax Measure



- The focus groups confirmed the viability of a commercial cannabis activity tax measure for November 2018
- Participants are happy with the City of Santa Clara generally and welcome additional improvements
- Although some were aware there is already a high tax on cannabis problem raising the tax because it would not affect them products and challenges for cannabis businesses, most had no personally.

Focus Groups: Bond Measure

- The focus groups confirmed voter hesitancy about the bond.
- The tax and cost information in the ballot question was confusing to participants (which is now required under AB 195).
- Many, especially homeowners, felt it was expensive on top of an already high cost of living
- Many talked about enjoying recent improvements to the city, such as updates to bring; however, they didn't see these projects as priorities for the City right now. parks, libraries, and bike paths, and were open to the improvements a bond could
- Although some have sentimental and appreciative ties to the Swim Center and upgrades did not align with their priorities for the City. many recognize needs for improvements, directing their tax dollars towards



Conclusions & Recommendations

Recommendations & Upcoming Activities

EMC research

- The City should proceed with planning for a Commercial Cannabis Activity funding measure, but should not proceed with a bond measure at this time
- Unfortunately, the consulting team concurs that a longer planning runway and waiting until a different election is necessary for the viability of a bond
