A RESOLUTION OF THE CITY OF SANTA CLARA, CALIFORNIA TO ADOPT THE SALARY SCHEDULE FOR EMPLOYEES REPRESENTED BY THE AMERICAN FEDERATION OF STATE, COUNTY AND MUNICIPAL EMPLOYEES, LOCAL 101 (UNIT 6)

## BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

WHEREAS, the 2017-2020 Memorandum of Understanding ("MOU") between the City of Santa Clara ("City") and the American Federation of State, County and Municipal Employees, Local 101 ("AFSCME" or "Unit 6") provided for a 3% salary adjustment retroactive to December 17, 2017, an additional 1% salary adjustment effective December 16, 2018, and an additional 2.5% salary adjustment effective December 2019;

WHEREAS, on April 24, 2018, Council approved the MOU with the noted salary adjustments; WHEREAS, the attached Salary Schedule applicable to AFSCME employees in Unit 6 should now be adopted and made effective December 16, 2018.

# NOW THEREFORE, BE IT FURTHER RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

- 1. That the City hereby adopts updated Salary Schedule G for AFSCME employees in its entirety as set forth in the attached Exhibit A. This revised salary schedule shall supersede any previously adopted salary schedule for the same effective date.
- 2. <u>Effective date</u>. This salary rates reflected in Exhibit A shall be effective December 16, 2018.
