STATUS SUMMARY

Healthier Kids Foundation is a family forward health agency that gives children and those who love them the education and cutting edge tools they rightfully deserve to live a healthy life. At Healthier Kids Foundation, we believe preventative care at an early age makes things fair. Every day, we work side-by-side with families to identify and eliminate kids' health issues before they even begin. Because without us, barriers that could be corrected may stand in the way of kids joyfully climbing the ladder of life. Healthier Kids Foundation is focused on providing services to children and families in the City of Santa Clara to ensure that every child has the opportunity to thrive in their community.

Healthier Kids Foundation has been funded by the City of Santa Clara to provide the following services during fiscal year 2017-2018:

- A minimum of 200 parents attending at least one 10 Steps to a Health You! (10 Steps) class
- 500 children ages 2-18 dental screened through DentalFirst program
- 500 children ages 2-18 hearing screened through HearingFirst program
- 1000 children ages 2-18 vision screened through VisionFirst program

In the City of Santa Clara, Healthier Kids Foundation screens children for undetected vision, dental, and hearing issues; and Healthier Kids Foundation case managers follow-up with the parents of all children who receive a screening result that is indicative of a potential issue. This ensures that each child gets the care they need to be successful in the classroom. Healthier Kids Foundation also delivers 10 Steps

to a Healthier You! workshops to parents and caregivers in the City of Santa Clara, providing strategies to implement healthy habits in the home.

Through funding provided by the City of Santa Clara during fiscal year 2017-2018, Healthier Kids Foundation was able to assist 45 kids in obtaining glasses, 20 kids in getting appropriate dental care, and 27 kids in obtaining appropriate hearing services. There are an additional 103 cases that case managers are continuing to work with to ensure treatment is reached. Without the funding provided by the city, it is quite possible that these children's needs would have remained unidentified, unaddressed and inhibited their ability to succeed in the classroom and in life.

Healthier Kids Foundation experienced challenges meeting the high deliverable set for the City of Santa Clara. For fiscal year 2017-2018 Healthier Kids Foundation relied on providing services to Santa Clara Unified School District sites to meet the goals. Screenings in these locations did not come to fruition. For fiscal year 2018-2019, Healthier Kids Foundation is focused on Santa Clara state preschools and other community based sites to reach the service deliverables.

In addition to the screenings and workshops provided, the City of Santa Clara Challenge Team has been effective in engaging stakeholders around the health and wellness of Santa Clara's youth. In quarter four, Challenge Team hosted the <u>Second Annual Challenge Team Essay Contest and Awards Banquet</u>. Where students who reside in the City of Santa Clara or attend a Santa Clara Unified School District school, submitted essays describing what health means to them. Thank you to the City Council for honoring the essay contest winners at a council meeting. Winners were also recognized at the Awards Banquet hosted by Challenge Team.

For those that are interested in participating, Challenge Team meets on the second Wednesday of every month, from 12:00-1:30 PM, at the Community Recreation Center (969 Kiely Blvd., Santa Clara, CA 95051).
