Action on Use Permit for ABC License Type 41 at 2047 El Camino Real 1.C 18-1143

**Recommendation:** Adopt a Resolution approving a Use Permit for the sale and service of beer and wine (ABC License Type 41) in an existing restaurant (Tay Ho), subject to conditions.

> Item was pulled by Commissioner Ikezi who wanted to confirm that food service is required for alcohol sales. Staff Liaison Gloria Sciara confirmed this type of ABC license requires that food be served at the restaurant.

In response to a question by Chair Jain, Staff Liaison Gloria Sciara noted alcohol and food sales can be extended until 10 p.m. as a revised condition of approval. Chair Jain requested that the applicant add bike racks, exceeding VTA guidelines. The Applicant supported the request subject to consent from landlord.

A motion was made by Commisioner Ikezi and seconded by Commissioner Kelly to approve this item with an amendment to extend alcohol being served until 10 p.m.with a condition to include a bike rack to the private portion of the property.

18-1213 Action on Use Permit to Allow Outdoor Play Area for a New Child Day

Care Facility at 1190 Benton Street

**Recommendation:** Adopt a Resolution approving the Use Permit to allow outdoor play area for a new child day care facility at 1190 Benton Street.

A member of the public, David Delozier, owner of neighboring properties, expressed his concerns regarding parking during the 6:00 p.m. pick up time which is a time when the adjacent parking lot is typically full. The Applicant spoke and noted the daycare will close at 6 p.m. and should not affect the parking for Franklin Square.

**Chair Jain** asked staff the regulations regarding required parking spaces for the facility. The applicant is providing 20 parking spaces and only 9 are required.

**Commissioner Chahal** requested that the applicant proactively provide signage regarding which parking spots are provided for he daycare. **Commissioner Kelly** requested that a 1-year review on parking.

A motion was made by Commissioner Ikezi and seconded by Commissioner Kelly approving the request with the condition that notice be given to employees of the child day care facility via an informational handout regarding drop off and pickups clarifying where restricted parking is for parents and staff and that the applicant have a 1-year review for compliance with parking.

# **PUBLIC HEARING**

2. 18-961 Public Hearing: Action on a Conditional Use Permit for Planet Granite to Allow a Climbing Gym and Outdoor Workout Area Located at 801 Martin Avenue

Recommendation: 1. Adopt a Resolution to Approve a Use Permit to allow a climbing gym and outdoor workout area located at 801 Martin Avenue, subject to conditions of approval.

> Assistant Planner I Steve Le presented the item. Item is a new use permit to allow a climbing gym for Planet Granite, the site was previously occupied by a fitness gym, Club One Fitness and has been vacant since 2013.

Commissioner Jain asked for clarification that this item is to a approve a use permit and not rezoning, which was confirmed by staff. Assistant City Attorney Alexander Abbe noted that assembly uses such as the proposed gym are conditionally permitted in the MH zone under the 'Bingo Exception' of SCCC Section 18.50.040, which allows for uses that are 'appropriate for an industrial area, such as lodges and bingo halls.

The Applicant gave a presentation about the benefits of the project. 10% of proceeds will be given to charitable organizations. The Applicant asked those in attendance who support the project to stand, and 17 attendees did SO.

Commissioner Ikezi asked questions regarding membership and opening dates - which is scheduled for Fall 2019. Commissioner Chahal complimented the owner on the healthy nature of project.

There were 2 public speakers who spoke in support of project, one specifically noted that due to her work with special needs children she was pleased to have this facility available to them.

A motion was made by Commissioner Becker and seconded by Commissioner Saleme that this item be approved.
