#### Please state reasons why you want to become a member of this Board/Commission/Committee, including what specific objectives you would be working toward as a member of this advisory board:

The Planning Commission plays a vital role in advising the City Council on matters affecting the present and future of Santa Clara. As a member of the commission, I hope to provide another voice and perspective to the City Council on how that present and future should look.

After living in Santa Clara for seven years, I have seen many changes in the city. The continued development of Santa Clara helps it stay relevant in an ever-changing economy. However, those changes also must not leave behind those that already living in the city. As the father of a young son, I see Santa Clara as a place where he can call home. I want to assure him that, while the face of the city may change, the heart of it does not.

My main focus as a commissioner will be ensuring that there is adequate affordable housing, which is also a priority for the city, given the Affordable Housing Ordinance. Although I am currently a homeowner, given today's housing market, I would now unlikely be able to afford a house in Santa Clara with median home prices nearing \$1 million. As I see friends contemplate moving their families out the Bay Area, if not California altogether, I firmly believe that new developments should have enough units that young families can afford. Families, in whatever composition, form the backbone of this community. We should do everything we can to keep families as part of the fabric of Santa Clara.

Another focus of my time as commissioner would be balancing growth with sustainability. As Santa Clara grows, structural problems become more apparent, especially traffic concerns. In order to lessen the impact of new housing developments, the city should have more specific plans such as the Lawrence Station Area Plan. By focusing housing around transit hubs, people will use cars less and public transportation more. Additionally, as a city with much more employment opportunities than housing, placing housing developments closer to the office buildings in our city would also reduce the need for cars, again lessening the impact on the daily lives of existing residents. Steady, intelligent growth in the city would positively affect the welfare of the entire community.

Santa Clara is a vibrant city that embodies the values of Silicon Valley. However, it faces the same problems afflicting the entire area. I firmly believe that I can help the city face those challenges by becoming part of the Planning Commission.

# Any other information which you feel would be useful to the City Council in reviewing your application:

Diversity in organizations such as the Planning Commission is important because it brings together a variety of viewpoints to create solutions for complex issues. I have spent much of my academic and professional life advancing the virtues of diversity through my work with a variety of groups.

During law school at the University of Virginia, I served as co-chair of the Student Bar Association's Diversity Committee. Every year, the law school has a diversity pledge, where students and faculty come together to sign the pledge affirming the value and importance of diversity. As a co-chair, I organized the event by bringing together the various affinity groups at the law school and soliciting sponsors for the event. The event resulted in hundreds of signatures for the pledge, showing the community at-large that the law school values inclusiveness.

Additionally, I am a member of the Diversity Committee at the Santa Clara County District Attorney's Office. I work with the group to establish hiring practices that allow our office to be representative of the county. We discuss and implement recruitment ideas to ensure the applicant pool for our job openings reaches people from all affinity groups.

As the Santa Clara County Representative of the National Asian Pacific Islander Prosecutors Association (NAPIPA), I have participated in many projects that further the organization's goal of promoting diversity. I, along with a co-author, published an article about NAPIPA and the importance of diversity in the California District Attorneys Association's *Prosecutor's Brief*, a publication read by all prosecutors in California. I help organize our annual scholarship banquet, which provides scholarships to Asian and Pacific Islander law students interested in becoming prosecutors. Currently, I am heading a project to create a video of various Asian and Pacific Islander prosecutors describing why they became prosecutors and the importance of minority representation in the field.

Given my work with these organizations, I will bring the lessons I have learned to the Planning Commission. By working together in a group with a diversity of ideas, I believe we can better serve the City Council and, ultimately, the City of Santa Clara.





I dedicated my academic and extracurricular experiences to beginning a public service career. My longterm goals are to graduate law school and become and elected official. I've developed capacities for policy analysis, community organizing, and social science-based research within nonprofit organizations along the Central Coast and in England. Since arriving back in the US, I've been searching for opportunities to serve my community. With news that the 49ers will receive up to \$30 million in city tax dollars this year, I believe the best place to serve my hometown is with the Planning Commission.

Santa Clara's most important public policy issue right now is city development, and millennial residents lack appropriate representation. The affordable housing shortage, public transportation improvements, and Levi's Stadium legal battles make this commission a focal point for the city's future. Millennials need to be a part of that decision-making process. Santa Clara University students, young adults commuting to work, and 20+-year-old stadium workers need more voice in high-stakes development negotiations. They need a Commissioner who will not approve new housing developments if they increase traffic congestion in high-density areas. They need a Commissioner who will hold large corporations accountable to our city's zoning ordinances, property taxes, regulations, and suburban communities. They need a Commissioner who will continue to investigate new development proposals thoroughly and publicly. More importantly, millennial residents need a Commissioner who can engage them and incorporate their insight and passion into the city development process. In short, I aim to dutifully serve the Planning Commission and work to bridge the gap between millennials and city development.

## KEITH STATTENFIELD PLANNING COMMISSION APPLICATION ATTACHMENT

I served on the Planning Commission for eight years, and enjoyed my time and think I made positive contribution to the development in Santa Clara. Over those years, the work of the commission touched on different things; initially most items coming forward were business and commercial development, then as the Great Recession hit California much of this dried up, and more residential developments came forward. Work on the General Plan update also changed what we the commission looked for in developments across the city, and the appropriateness of scale and density that were being encouraged.

On the commission, I tried to balance the needs and requests of existing residents with each project that came before the commission. I tried to fairly evaluate each project, keeping in mind that the commission needs to ma the required findings under the law before voting to approve a project. I think the role of the planning commission is to look at each proposal and approve those that meet the guidelines and findings, and recommend against (with suggestions for how to resolve issues) those that go against the general plan or other zoning issues.

On those issues that don't require findings or that go to the city council for final approval, including recommendations for subdivision, general plan changes, etc, I think that the commission should work hard to make sure that the city and community get a significant benefit out of allowing whatever changes an application requesting.

I served on the architectural approval subcommittee for most of my time on the Planning Committee, and there, many of the issues boiled down to trying to get neighbors to compromise and maintain some level of compatibily and privacy with increased density. For issues like this, I'd continue what I think was usually successful mediations, while generally permitting property owners to develop their homes and businesses in line with the la and adopted policies.

The biggest issue I see that the city faces, today and into the future, is the significant housing deficit that the entire area has compared to the number of jobs, which leads to increased traffic and congestion, and to residents and businesses getting priced out of the area. To that end, I am generally supportive of increased development, consistent with the general plan and with any special plans that eventually get implemented. However, we also need to hold developers to the promises they make to mitigate impacts,

since those impacts persist long after they've completed their project, and the city needs to have policies and guidelines about what we expect in terms of making a proposed development mesh with the neighborhood and provide benefits not just to that project bu to the city as a whole. This creates and bleed over into other issues as well, like transit and pedestrian/ bicycle access, sufficient park and recreation space, etc., all of which have the potential to improve or degrade our community.

Although I've been off the commission for a few years, I've tried to stay in touch with the issues, and watch or listen to many of the meetings online still. I am obviously familiar with the processes of the commission, can make time for the meetings and expect to prepare for and attend almost all of the meetings, and would plan to also attend educational seminars or conferences as they were available to keep my knowledge up to date.
