### **RESOLUTION NO. 19-8723**

## A RESOLUTION OF THE CITY OF SANTA CLARA, CALIFORNIA ESTABLISHING FISCAL YEAR 2019/20 APPROPRIATIONS LIMIT PURSUANT TO ARTICLE XIIIB OF THE CALIFORNIA STATE CONSTITUTION AS IMPLEMENTED BY TITLE 1, DIVISION 9 (ENTITLED "EXPENDITURE LIMITATIONS" – SECTION 7900 ET SEQ.) OF THE CALIFORNIA GOVERNMENT CODE

### BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

WHEREAS, Proposition 4, commonly known as the Gann Initiative, was adopted by voters on

November 6, 1979;

WHEREAS, the Proposition created Article XIIIB of the California State Constitution placing

limits on the amount of revenue which can be spent by all entities of government;

WHEREAS, the limit based on the Proposition 4 formula is updated annually using growth data

supplied by the State Department of Finance; and,

WHEREAS, the appropriation limit is required to be adopted by the legislative body of each

government entity.

# NOW THEREFORE, BE IT FURTHER RESOLVED BY THE CITY OF SANTA CLARA AS

### FOLLOWS:

 <u>Appropriations Limit</u>. That the appropriations limit for fiscal year 2019/20 be Four Hundred Seventy Eight Million Nine Hundred Forty Five Thousand Three Hundred and Sixteen Dollars (\$478,945,316).

2. <u>Calculation Factors</u>. Pursuant to Section 8 of Article XIIIB of the California Constitution, the City Council determines that for fiscal year 2019/20 the change in the cost of living shall be measured by the percentage change in California per capita personal income or the growth in the non-residential assessed valuation due to new construction within the City and the change in population shall be measured by the annual growth in the County or the City's population as provided by the State Department of Finance, whichever is higher.

3. <u>Factors for 2019/20</u>. That for purposes of computing the appropriations limit for fiscal year 2019/20, the annual growth in the California Per Capita Income is 3.85% and the annual percent change in County population as provided by the State Department of Finance is 0.33%.

4. <u>Notice of Action to be Taken</u>. Pursuant to Government Code Section 7910, no judicial action or proceeding to attack, review, set aside, void, or annul the action of the City Council in establishing the appropriations limit for fiscal year 2019/20 shall be brought unless such action or proceeding shall have been commenced within forty-five (45) days of the date of adoption of this resolution.

5. <u>Effective date</u>. This resolution shall become effective immediately.
