1. Call to Order and Roll Call

City Clerk Haggag called the Charter Review Committee meeting to order at 6:01 p.m.

3. Review of the Brown Act

City Attorney Doyle gave a PowerPoint Presentation on the Brown Act.

4. Selection of Chair/Vice-Chair

City Clerk Haggag led the group through the process. Committee members nominated a fellow member for Chair and then the Committee voted. **City Clerk Haggag** also explained that the Chair's role is to run the meetings and the Vice-Chair would do the same in the absence of the Chair.

Committee members nominated Member Jain, Member Bonito and Member Ricossa for Chair. Each person accepted the nomination and gave a brief summary of why they should be Chair.

In the initial vote:

Member Jain received 3 votes
Member Silva received 3 votes
Member Ricossa received 1 vote

In the second vote:

Member Jain received 4 votes
Member Silva received 3 votes

Member Jain nominated Member Silva as Vice-Chair.

A motion was made by Member Koltermann seconded by Member Bonito, to approve Member Jain as Chair and Member Silva as Vice-Chair.

Public Speaker 3 supports six districts.

Public Speaker 4 suggested that any outreach flyers be translated to help encourage participation.
