Recommendation: 1. Sustain the appeal and modify the decision of the Architectural Committee on June 19, 2019 to allow five bedrooms and four and half bathrooms with an exterior access for Bedroom #1.

Recommendation:

Alternative 1:

Recommend City Council adopt an Ordinance to amend Chapter 18.76 Architectural Review of the City of Santa Clara Zoning Code to amend the existing Architectural Committee process to modify the composition of the Architectural Committee to be composed of three Planning Commissioners, to clarify which projects are subject to Architectural Review by the Architectural Committee, to clarify that decisions are appealable to the City Council on a *de novo* basis and changes to the appeal procedures so that appeals are available to the applicant, property owners, and residents within 500 feet of the project boundary.

Principal Planner John Davidson provided a presentation.

A motion was made by Commissioner Ikezi, seconded by Commissioner Kelly to recommend approval of this item with the following conditions:

Amend Condition C1A to 5 or more bedrooms; C1B to 5 or more bathrooms and C1C to Two or more bedrooms with direct exterior access. Anything below that would go to administrative approval.

That the Architectural Review Committee be made up of 3 Planning Commissioners.

Amendments were made to Item C5 to change 5,000 to 10,000 square feet in size. Item 7d. to be changed to for all multi-family attached residential developments and for all commercial developments greater than 20,000 square feet area, include the input from a practicing architect with similar experience or a similar practice who is required to attend the relevant Planning Commission hearing, at applicant's expense.
