

#### **Regulatory Background**

- Assembly Bill 1826 (2014)
  - Requires commercial customers to divert organics materials from landfills
- Senate Bill 1383 (2016)
  - 50% reduction of organic waste disposal by
     2020 from 2014 level
  - o 75% reduction of organic waste disposal by 2025 from 2014 level
  - Mandates cities implement organic waste diversion programs





#### **Current Agreements**

- Mission Trail Waste Systems (expires 12/30/21)
  - o Residential garbage & organics
  - o Commercial garbage & recycling at all properties not zoned for "Industrial" use



- Republic Services/BFI (expires 12/31/24)
  - o Landfill disposal (\$49.76/ton)
  - o Composting of source separated green waste (\$40.91/ton)
  - o No mixed waste processing





#### **September 27, 2019 Council Direction**

- Organics collection program options and costs overview:
  - o Split-cart
  - o Organics in green waste cart
  - o Mixed waste processing
- Council directed staff to:
  - o Pursue the split-cart and mixed waste processing
  - o Finalize terms with MTWS
  - o Enter into negotiations with GWR



# Organics Collection Program Options Single-Family and Townhouse

- Option 1 Split-Cart Program
  - o Expands split-cart pilot program City-wide
  - o All customers receive split garbage/organics cart
  - o Food scraps/soiled paper directed to the SAFE facility

#### OR

- Option 2 Mixed Waste Processing Program
  - o Requires new agreement with GWR to implement
  - o Includes food scraps/soiled paper in garbage containers
  - o Garbage processed at GWR to remove organics



#### **Option 1 – Split-Cart**

- Advantages:
  - Lowest cost for single-family and townhouse customers
  - Feeding animals is higher and better use of food scraps than composting
- Disadvantages:
  - Highest cost for commercial business and multi-family customers
  - Carts have larger footprint, weigh more, durability issues
  - o Loss of garbage capacity
  - $\circ\,$  More public outreach required



# Option 2 – Mixed Waste Processing (organics in garbage cart)

- Advantages:
  - Lowest cost for commercial business and multi-family customers
  - Implemented using existing containers
  - o No additional sorting
  - o Highest diversion rate

- <u>Disadvantages</u>
  - Highest cost for single-family and townhouse customers
  - Lower quality organic waste recovery



#### **Community Outreach**

- · Community Meetings October 21 and 24, 2019
  - o 9 residents in attendance
    - 89% support Option 1 source separated organics in split-cart
    - 11% support Option 2 organics in garbage cart (mixed waste processing)
- Survey Results November 4-22, 2019
  - o 643 responses
    - 37% support Option 1 source separated organics in split-cart
    - 63% support Option 2 organics in garbage cart (mixed waste processing)



# Organics Collection Program Options Commercial/Multi-Family

- Option A Third Container for Organics
  - o Requires all commercial and multi-family customers to subscribe to an additional container and source separate organics (food scraps/soiled paper)
  - o Food scraps directed to SAFE facility and food soiled paper to compost facility

#### OR

- Option B Mixed Waste Processing Program
  - $\circ\,$  Requires new agreement with GWR to implement
  - o Garbage from existing containers processed to capture organics for composting
  - o Organics third cart not required commercial businesses and multi-family could still voluntarily subscribe to MTWS food scraps recycling program



# Proposed Agreement Terms with GreenWaste Recovery



#### **Wage for Sorting Labor**

- Sorting Labor not covered under Prevailing Wage
  - $\circ$  No applicable wage classification per the Department of Industrial Relations
- GWR Pays Sorting Labor a San Jose Modified Living Wage
  - o Current Hourly Wage Rate \$18.51/hr. plus benefits
- If directed by Council, a Living Wage specific to Santa Clara could be established but it would be a City-wide policy direction beyond this agreement.
  - o Delays agreement and schedule
  - o No other alternatives for mixed waste processing
  - o GWR would need to develop pricing after Santa Clara living wage established
  - $\circ\,$  Results in higher per ton costs and higher customer rates
  - o The Agreement allows for this change

#### **GreenWaste Labor**

- GWR utilizes both union and non-union labor
- Employees can decide to form a union
- Examples of GWR union contracts include:
  - o Operating Engineers Local Union #3 (Santa Cruz/Scotts Valley/Capitola)
    - Drivers and MRF Operators
  - o Local Laborers #270 (7 Monterey Peninsula jurisdictions)
    - Drivers, utility and shop workers
- Charles Street MRF is currently non-union pays San Jose Living Wage per Ordinance (Modified)
- City cannot by law require union labor



#### **GreenWaste Agreement Terms**

- January 1, 2021 June 30, 2036 (mutual option for 5-year extension)
  - o Term aligns with Recology and MTWS agreements
  - o Per ton rates adjusted annually based on CPI change
  - $\circ$  5-year term evaluated: \$45/ton more expensive for commercial, \$51/ton more expensive for residential
- Garbage container contents delivered to a facility in San Jose for mixed waste processing - \$165/ton (residential) or \$171/ton (commercial)
  - o Organic material sent to Z-Best Compost facility in Gilroy
  - o Non-organic recyclables recovered and marketed
  - o Residual garbage sent to Newby Island Landfill (City pays disposal)



#### **Future Flexibility**

- Secures long-term processing of residential recyclables
  - o Recology currently delivers recyclables to the GWR material recovery facility
  - o Future commodity pricing fluctuates with a composite price index
- Enables Council to select mixed waste organics collection programs Option 2 (residential) and/or Option B (commercial/MFD)
  - MTWS able to market SAFE program for food scraps under Option B (commercial MFD)
- Opportunity to secure future services after 2024
  - o Residual Garbage Disposal
  - $\circ\,$  Compost source separated green waste



### Proposed Agreement Terms for Mission Trail Waste Systems



#### **MTWS Agreement Terms**

- July 1, 2020, through June 30, 2036, with mutual 5-year option
- Maintains exclusive collection rights for the following sectors:
  - o Single-family
  - o Multi-family
  - o Commercial businesses
- Commercial recyclables and food scraps processing
- Compensation increases dependent upon organics collection program (Option 1 or Option 2)



### MTWS Compensation Increase (Single-Family, Townhouse, Commercial and Multi-Family)

Option 1 Organics in split-cart	4.5%	8%	7%
Option 2 Organics in Garbage	6.0%	9%	9%



### **Other Significant Terms**

- New CNG Trucks
- Construction & Demolition Debris Recycling
- New MTWS Program Manager education, reporting and compliance
- On-call Bulky Item Collection Program New alternative
- City Roll-off Boxes Up to 100 boxes (30 C.Y.) per year
- Additional Reporting In line with current State laws
- Annual CPI Adjustments Start July 2023 5% max / 2% min
- Continuation of existing services
  - $\circ\,$  Up to 96 gallons/week commercial recycling at no charge
  - $\circ$  2 free resident only disposal events

#### **Public Hearing: Agreement with GWR**

Council must first approve an agreement with GWR prior to including Option 2 and/or Option B into an agreement with MTWS.

#### **Staff Recommendation:**

- Approve and authorize the City Manager to execute an agreement with GWR for solid waste processing, transfer, transport, recycling, and disposal services
- Authorize the City Manager to make minor modifications to the agreement, if necessary



### Public Hearing: Agreement with MTWS

#### **Staff Recommendation:**

- Direct staff to incorporate Option 2 maintain the existing garbage container for single-family and townhouse customers and deliver the contents to a mixed waste processing facility to recover the organics into the agreement
- Direct staff to incorporate Option B mixed waste processing of garbage with no additional container required for commercial business and multi-family customers into the agreement
- Approve and authorize the City Manager to execute an agreement with Mission Trail Waste Systems containing the terms outlined in the term sheet
- Authorize the City Manager to make minor modifications to the agreement, if necessary
