## BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

WHEREAS, the City established certain parking regulations on Alfred Street and Jay Street;
WHEREAS, certain property owners (the Muslim Community Association) expressing concerns
regarding parking problems requested Staff to modify parking regulations on Alfred Street and

Jay Street;

**WHEREAS**, City Traffic Engineering staff surveyed all property owners affected by the request and determined that modifying the existing parking regulations would best accommodate these affected properties for improved safety, parking conditions and quality of life.

**WHEREAS**, the City intends to repeal the existing parking regulations on Alfred Street and Jay Street; and

**WHEREAS**, the City intends to establish new parking regulations on Alfred Street and Jay Street based on a survey of all affected property owners in the area.

Vehicles in Excess of 20 feet" zone on both side of Jay Street, from Duane Avenue to Scott

Boulevard.

10. That there is hereby established a combined "2-hour at Any Time" and "No Parking for

Vehicles in Excess of 20 feet" zone on the west side of Alfred Street, between Duane Avenue

and Space Park Drive.

11. That there is hereby established "2-hour at Any Time" zone on the east side of Alfred

Street, from Duane Avenue to a point 889 feet south of the south curb of Duane Avenue.

12. That there is hereby established a "No Parking for Vehicles in Excess of 20 feet" zone

on the east side of Alfred Street, between Duane Avenue and Space Park Drive.
