A RESOLUTION OF THE CITY OF SANTA CLARA, CALIFORNIA APPROVING THE APPOINTMENT OF THE SANTA CLARA TOURISM IMPROVEMENT DISTRICT ADVISORY BOARD

## BE IT RESOLVED BY THE CITY OF SANTA CLARA AS FOLLOWS:

WHEREAS, the Santa Clara Tourism Improvement District ("TID") was established in January 2005, by adoption of Article IX entitled "Santa Clara Tourism Improvement District" of Chapter 16.10 of the Santa Clara Municipal Code ("SCCC"), and is generally located in the northern portion of the city, as more particularly described in Resolution No. 7176;

**WHEREAS,** Chapter 16.10 of the SCCC, also established a District Advisory Board (the "Advisory Board") to administer the affairs of the TID and the Advisory Board is constituted of representatives of businesses within the TID;

WHEREAS, in accordance with the requirements of Streets and Highways Code Section 36530, an Advisory Board is appointed by the City Council to make recommendations to the City Council regarding the expenditure of revenues derived from the levy of assessments, on the classification of businesses, as applicable, and on the method and basis of levying the assessments;

WHEREAS, the TID currently includes nine hotels: Avatar Hotel, Biltmore Hotel & Suites, Embassy Suites, Hilton Santa Clara, Hyatt House, Hyatt Regency, Marriott Santa Clara, The Plaza Suites, and TownePlace Suites by Marriott; and,

**WHEREAS**, in accordance with the requirements of Streets and Highways Code Section 36530, the City Council is appointing the TID Advisory Board membership to those persons paying the assessment.
