AMENDMENT NO. 2 TO THE AGREEMENT FOR SERVICES BETWEEN THE CITY OF SANTA CLARA, CALIFORNIA, AND REED MATTHEW DILLINGHAM DBA DILLINGHAM ASSOCIATES

PREAMBLE

This agreement ("Amendment No. 2") is entered into between the City of Santa Clara, California, a chartered California municipal corporation (City) and Dillingham Associates Landscape Architects a California Sole Proprietorship, (Contractor). City and Contractor may be referred to individually as a "Party" or collectively as the "Parties" or the "Parties to this Agreement."

RECITALS

- A. The Parties previously entered into an agreement entitled "Agreement for Design Professional Services Between The City Of Santa Clara, California, and Dillingham Associates Landscape Architects, dated September 27, 2018 (the "Original Agreement"); and
- B. The Agreement was previously amended by Amendment No. 1, dated September 5, 2019, and is again amended by this Amendment No. 2. The Agreement and all previous amendments are collectively referred to herein as the "Agreement as Amended"; and
- C. The Parties entered into the Agreement as Amended for the purpose of having Contractor develop conceptual design options, plans and specifications and construction documents for the improvement project at Raymond G. Gamma Dog Park, including additional time, civil engineering services, permit and construction sets, and the Parties now wish to Amend the Agreement As Amended to include funding for construction administration and additional services as needed to complete the Project expeditiously.

NOW, THEREFORE, the Parties agree as follows:

AGREEMENT TERMS AND CONDITIONS

1. The Section entitled "Exhibit A Scope of Services" of the Agreement as Amended, entitled "Agreement For Design Professional Services Between The City Of Santa Clara, California, and Dillingham Associates Landscape Architects" is amended to read as follows by adding Exhibit A-2 Additional Scope of Services, attached hereto and incorporated by this reference.

- 3. Except as set forth herein, all other terms and conditions of the Agreement as Amended shall remain in full force and effect. In case of a conflict in the terms of the Agreement as Amended and this Amendment No. 2, the provisions of this Amendment No. 2 shall control.
