Background

Tasman East Specific Plan

- Adopted by City Council on November 13, 2018
- 4,500 units and 100,000 sf retail on 45 acres at the northeast corner of Tasman Drive and Lafayette Street





Background

Infrastructure Fee Concept

- Establish an Infrastructure Impact Fee for equitable distribution of common infrastructure
- Nexus Study Economic & Planning Systems, Inc.
- One-time fee charged to new residential development
- Fees used to finance capital facility/infrastructure costs
- Fees based on a reasonable relationship (i.e., nexus)

Infrastructure Items

Construction Improvements \$29,543,974

- Sanitary sewer (Primavera Pump station upgrades)
- Storm drainage
- Water (Potable and Recycled)
- Pavement repair
- · Pedestrian and bicycle paseo
- Sidewalks
- Traffic improvements

Infrastructure Items

Engineering/Fee Studies and Annual Staff Costs

- Two sanitary sewer engineering studies (\$132,000)
- Nexus fee study completed (\$20,000)
- 2% Annual staff costs to administer Fee program (\$593,920)

Infrastructure Fee

Additional Considerations

- Developer can build improvements and receive fee credits or reimbursement
- Adjust fee annually by Engineering News Record (ENR)
 Construction Cost Index for San Francisco

Resolution, Ordinance, and Budget Actions


- Resolution (Adopt Fee and Nexus Fee Study)
- Ordinance (Establish City Code related to Fee)
- Budget Actions (Establish fund, revenue, and expenditure)



Recommendation

- 1. Approve the Tasman East Specific Plan Infrastructure Impact Fee; and adjust fees annually in line with the latest Construction Cost Index for San Francisco, as published by Engineering News Record or equivalent, in order to keep up with construction costs and inflation.
- 2. Adopt a Resolution Approving the Findings from the Tasman East Specific Plan Infrastructure Impact Fee Nexus Study and Setting the Rates for the Infrastructure Impact Fee.
- 3. Approve the Introduction of an Ordinance adding subsection 17.15.350 to the Santa Clara City Code.
- 4. Approve the establishment of the Tasman East Infrastructure Improvement Fund (Fund 541) to account for the impact fee revenues and project expenditures and related budget amendments.
