As it was explained at the meeting, this project (including the second floor balcony) was previously approved at the Development Hearing on May 13, 2020 and is currently undergoing construction after receiving the building permits. The only reason the project was scheduled again for the hearing was because they added additional 18 sq. ft. on the second floor balcony and it was not up for reconsideration. Thanks.


