#### AMENDMENT NO. 2 TO THE AGREEMENT FOR SERVICES BETWEEN THE CITY OF SANTA CLARA, CALIFORNIA, AND MOORE IACOFANO GOLTSMAN, INC.

#### PREAMBLE

This agreement ("Amendment No. 2") is entered into between the City of Santa Clara, California, a chartered California municipal corporation (City) and Moore Iacofano Goltsman, Inc., a California corporation, (Consultant). City and Contractor may be referred to individually as a "Party" or collectively as the "Parties" or the "Parties to this Agreement."

#### RECITALS

- A. The Parties previously entered into an agreement entitled "Agreement for Services", dated July 17, 2018 (Agreement);
- B. The Agreement was previously amended by Amendment No. 1, dated June 12, 2020, and is again amended by this Amendment No. 2. The Agreement and previous amendment are collectively referred to herein as the "Agreement as Amended"; and
- C. The Parties entered into the Agreement as Amended for the purpose of having Consultant prepare a Specific Plan for the Patrick Henry Drive plan area, and the Parties now wish to amend the Agreement as Amended to expand the scope of services and increase the total compensation.

NOW, THEREFORE, the Parties agree as follows:

#### AMENDMENT TERMS AND CONDITIONS

- 1. Section 6 of the Agreement as Amended, entitled "Compensation and Payment," is amended to reflect a revised maximum compensation of \$1,017,623.
- 2. Exhibit A, entitled "Scope of Services" is appended with the attached "Addendum to Scope of Services."
- 3. Exhibit B, entitled "Schedule of Fees," is amended to reflect a revised maximum compensation of \$1,017,623.
- 4. Except as set forth herein, all other terms and conditions of the Agreement as Amended shall remain in full force and effect. In case of a conflict in the terms of

the Agreement as Amended and this Amendment No. 2, the provisions of this Amendment No. 2 shall control.

The Parties acknowledge and accept the terms and conditions of this Amendment No. 2 as evidenced by the following signatures of their duly authorized representatives.

# **REPORT TO COUNCIL**

## <u>SUBJECT</u>

Action on Amendment No. 2 to the Agreement with Moore Iacofano Goltsman, Inc., for preparation of the Patrick Henry Drive Specific Plan and Related Budget Amendment

## COUNCIL PILLAR

Promote and Enhance Economic, Housing and Transportation Development

## BACKGROUND

The City formally commenced preparation of a Specific Plan for the Patrick Henry Drive (PHD) area following the City Council's approval of a contract on August 22, 2018 with planning consultants, Moore Iacofano Goltsman, Inc. (MIG). The Patrick Henry Drive Specific Plan area is designated as a Phase III Future Focus Area for high-density residential development in the City's 2010-2035 General Plan. Preparation of the Specific Plan will identify new General Plan land use designations and associated policies for urban design, amenities, infrastructure, and other land use elements to support the redevelopment of the PHD area from low-intensity office and industrial park use into high-density, mixed use neighborhoods.

The existing Agreement with MIG was amended on June 6, 2020, to extend the termination date and add a unique land-use designation for one of the property owners. The Agreement is fully funded by a Reimbursement Agreement with property owners within the plan area.

## DISCUSSION

Staff is proposing Amendment No. 2 to the Agreement with MIG to expand the scope to include additional services. As the project has developed, additional tasks were identified by staff working with the Plan area owners as desirable to include within preparation of the Specific Plan, primarily related to sewer and traffic analyses. Specific to the traffic analysis, after reviewing the results of the preliminary traffic analysis and discussing the scope of analysis with the Plan area stakeholders, staff is proposing to expand the project scope and budget to allow for the analysis of a cumulative "no project scenario" as well as scenarios without the addition of a proposed connection from Patrick Henry Drive southward to Mission College Boulevard. The City made the determination to modify the analysis after the consultant scope of work and project budget was developed. These additional analyses will provide the City with more flexibility for its future decision-making process. Additional funding for the consultant team is needed to support these added and modified tasks. The Advanced Planning Reserve will fund the City initiated changes made to the scope for the traffic analysis while the stakeholders will be funding the sewer analysis and "no project scenario" traffic analysis. Staff is preparing an amendment to the Reimbursement Agreement with the Plan area property owners to align with the amended MIG Agreement and to update the cost allocation for each of the property owners.

The City Manager has authority to execute Reimbursement Agreements with valuations of less than \$250,000; however, the valuation for the Reimbursement Agreement for the Patrick Henry Specific Plan exceeds this existing authority. The proposed amendment to the Reimbursement Agreement will be brought forward to Council following the execution of the amended consultant agreement.

### ENVIRONMENTAL REVIEW

The action being considered does not constitute a "project" within the meaning of the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines section 15378(b)(5), in that it is a governmental organizational or administrative activity that will not result in direct or indirect changes in the environment. For the underlying project, the Patrick Henry Drive Specific Plan, the City will prepare an Environmental Impact Report (EIR).

#### FISCAL IMPACT

Amendment No. 2 with MIG increases the total valuation of the agreement by \$129,000 to a total not to exceed amount of \$1,017,623. Of the \$129,000 increase, \$103,000 will be funded through an amended reimbursement agreement with property owners within the Patrick Henry Specific Plan and \$26,000 will be funded through the Advanced Planning Reserve to fund the traffic analysis.

Following the approval of Amendment No. 2, the developer will deposit \$103,000 in the City's Deposit Fund from which payments will also be made. The remaining amount of \$26,000 will be paid through the Community Development Department using the Advanced Planning Reserve. The proposed budget amendment below allocates funding from the Advanced Planning Reserve to the Community Development Department of \$26,000.
