#### Request

Amend the existing Use Permit (PLN2018-13414) for outdoor activity associated with the child daycare/preschool facility to allow the expansion of the existing facility and modify the existing outdoor activity area on two contiguous parcels located at 2931 El Camino Real.



#### **Background**

- Child Care Facility is an allowed use in the Commercial Throughfare (CT) Zoning District.
- Per SCCC Section 18.38.040(c), outdoor activity associated with the permitted use is required to obtain a Use Permit.
- On October 24, 2018, Planning Commission approved a Use Permit (PLN2018-13414) to allow 12,650 square foot outdoor activity associated with the proposed child daycare/preschool facility (Vidyarambh).

- Site Area: 1.33 acres
   (58,000 sq. ft)
- General Plan: Community Mixed Use
- Zoning: (CT)
- Approximately 40,698 square feet of the space leased to current Child daycare facility.


Site Plan

# **2931 El Camino Real** Existing Facility


- 9,000 sq. ft. one story building

- 28 Parking spaces
- 167 children (70 full time, 97 part time), max 120 children at a given time.
- 9-12 staff members.
- Operates Monday through Friday from 8:00 a.m. to 6:30 p.m.





#### **Proposed Extension**


- 4,307 sq. ft. modular building
- 5 classrooms, offices/reception area, and a kitchen
- 11,700 sq. ft. outdoor activity area
- 44 Parking spaces
- Additional 73 children (48 full time, 25 part time).
- Additional 9-12 staff members.
- Operates Monday through Friday from 8:00 a.m. to 6:30 p.m.





# **2931 El Camino Real** Proposed Extension













#### **Proposed Child Daycare Facility**

- The applicant provided a trip generation analysis prepared by Hexagon Transportation Consultants, Inc. The analysis concluded that project would generate fewer than 100 peakhour trips and additional traffic studies are not necessary.
- A noise study was conducted to analyze the noise impacts from the new building to the adjacent residential developments found the noise levels to be within the allowable limits indicated in the General Plan.



#### **Public Comments**

- No Public Comments have been received in support or in opposition of the project.
- No reported violations or service notices on the existing facility.



#### **Staff Recommendation**

Adopt the Resolution to approve the amendment to the existing Use Permit (PLN2018-13414) for outdoor activity associated with a child day care facility at 2931 El Camino Real, subject to conditions of approval.
