Growing up in Santa Clara I remember attending cultural events and being very involved in the local community. After going to Ohio for college and now in my mid 20-s I have made the choice to move back to work in the Bay Area and live in Santa Clara. However, I do not see that same level of engagement within the community today that I experienced while growing up here.

While the city is doing a great job to connect with children and older populations, I feel that young professionals are not getting the engagement they need today to stay in Santa Clara. Increasing program offerings that are led by the community and that are for the community will reflect the diverse culture we have in Santa Clara and create a sense of belonging.

Though my experiences of working on projects with organizations like the California African American Museum and The Music Center in Los Angeles in partnership with the USC lovine and Young Academy, I have learned that programming must be centered around who it is serving and properly communicated. I hope to bring my energy and new perspective to the Cultural Commission with the goal of revitalizing city events to be more appealing & inclusive,

increase community engagement across different age groups (with an emphasis on people in their 20s and 30s), create shared value between the city and its residents through programming, and instill a sense of pride and belonging while living in Santa Clara.
