
#### **Finn Chiller Update**



- 1. August '20 a faulty circuit board on the Chiller's Compressor #1 was repaired & the sound was mitigated.
- 2. Sept '20 Colin Gordon Sound Engineers completes a sound study which concluded the sound DOES NOT exceed City Sound Ordinances.
- 3. Oct '20 Sound Panels were installed around the chiller's frame.
- 4. Jan '21 several neighbors reached out to SCU to inform the noise had returned.
- 5. April '21 SCU works SVM/Vibro Acoustics to provide SCU with a proposal for a sound absorbing wall.
- 6. May '21 SCU **Wilson Ihrig Sound Engineers** completes a six day sound study. Readings of 40dB to 70+dB.
- 7. June '21 ABCS Mechanical adjusts the chiller's load limit to 40% at 8 pm each night. Sound in the evening was mitigated.
- 8. August '21 Trane Mechanical locates a "blown" 40 amp fuse for chiller main fans. Fuse was replaced and daytime sound was mitigated.



# Fall 2021 Campus Updates

- 98% (99% of Undergrads and 98% Graduate) students have been verified as vaccinated
- 98% of staff and faculty have been verified as vaccinated
- SCU hosted 3 vaccination clinic on campus in collaboration with the Santa Clara County Health Department.
- <u>COVID dashboard</u>- Updated weekly with total number of tests, positivity rates and potential exposures by building & date
  - 7-day test positivity rate of less than 0.1%, lower than the 1.1% positivity rate in <u>Santa Clara County</u>, as of October 8th, 2021
  - 10 positive cases since September 17th, 2021
- Following state and Santa Clara County public health directives, SCU works with the Santa Clara County Health Department to identify cases, notify appropriate parties, and quarantine close contacts.





### **Testing Information**

- As of Friday, September 17, all students—even those who are fully vaccinated participated in <u>mandatory entry testing</u>. Further, all resident undergraduates will be <u>required to test weekly</u> throughout the fall term. Those with qualified <u>exemptions from</u> <u>vaccination</u> are required to test weekly.
- Mandatory Fall 2021 Entry Testing
  - All students participated in mandatory entry testing. 3 self administered tests during the first 3 weeks of classes.
  - All on-campus resident undergraduates are required to test weekly for COVID-19 during the fall 2021 term.
  - Off-campus students are strongly encouraged to participate in weekly testing even if they are not attending classes face to face.
- Self administered tests are free and available in locations throughout campus.
- All COVID related policies and protocols are located on the <u>Prepared SCU website</u>.

- OCL, SCPD and Code Enforcement conducted the annual Walkabout on September 25th.
- 157 residences were visited. Each house was given information about city codes and ordinances, tips for good neighboring, City of Santa Clara resources & COVID protocols and policies.
