Please note that the verbal report of action taken in closed session on March 20, 2018, regarding *In re David Tanquary* (Workers Compensation Appeals Board Case Nos. ADJ9923375, ADJ9820047, ADJ9820053), RTC 18-314, was inadvertently stated incorrectly. The approved settlement figure was verbally stated to be \$70,000 while the actual settlement amount approved in closed session by the City Council by unanimous vote was \$78,662.50.
