Mayor Gillmor proposed a substitute motion, seconded by Councilmember Watanabe: to (1) direct the City Manager to provide exemptions under Conditions of Approval P22(c) for up to five weeknight concerts per year, including pyrotechnics, that are scheduled to end no later than 11:00 PM Sunday through Thursday; (2) direct the City Manager to provide those exemptions within 48 hours of a request to the Stadium Manager when requested; and (3) if there are additional requests for an exemption beyond those five exemptions, direct the City Manager to bring the requests to Council for consideration where the Council will weigh the pros and cons subject to:

- (1) before a new curfew policy or pilot program goes into effect, the Stadium Manager must adhere to all legal agreement violations;
- (2) before a new curfew policy or pilot program goes into effect, the Stadium Manager must demonstrate that they have complied with all State and Local labor laws, including Wage Theft violation;
- (3) curfew violations shall result in fines that should be sufficient to deter curfew violations and shall be increased for repeat violations City Staff should research effective fines and policies to enforce curfew;
- (4) three curfew violations shall result to the original curfew policy for one year to demonstrate that the Stadium Manager can effectively manage these events:
- (5) the Stadium Manager cannot book money losing events or events that

are a financial burden for the Stadium Authority, the City General Fund, and the City of Santa Clara taxpayers; and
(6) the Stadium Manager must pay for specific Public Safety resources for all events so all Santa Clara neighborhoods do not see a reduction in Police patrol during Stadium events.

Assistant City Clerk Pimentel noted that a motion to consider the substitute motion would need to occur.

A motion was made by Mayor Gillmor, seconded by Councilmember Watanabe, to consider the substitute motion made proposed by Mayor Gillmor and Councilmember Watanabe.
