A motion was made by Councilmember Watanabe, seconded by Mayor Gillmor, to confirm the recommended Green House Gas target for the Climate Action Plan update and set the city's target to be more aggressive than the State of California Guidelines including the all electric reach code and add the following: intermediate goal target of 80% emissions reduction by 2035 while keeping the proposed 100% by 2045 target, and 25% VMT reduction from Active Measures aside from proximity to public transit, one secured biking parking spot per unit with electrical outlets for charging electric bikes, City to adopt a policy for City buildings to replace gas furnace with an electric equivalent on burnout, implement an Emissions Tracking Dashboard, facilitate Work-From-Home by improving the City's internet access & fiber, and to adopt an all Electric Reach code and changing the proposed EV charging 75% Level 1 requirement to Level 2 light at 3.8 Kw using an automatic load management software to balance the loads. (update it from proposed 25% level 2 and 75% level 1 to 25% level 2 and 75% light level 2 at 3.8kW).

If a person wishes to challenge the nature of the above section in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Santa Clara, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.
