### **SUBJECT**

38<sup>th</sup> Annual Art & Wine Festival-Event Evaluation

### **BACKGROUND**

The Parks & Recreation Commission hosted the 38<sup>th</sup> annual Santa Clara Art & Wine Festival in Central Park on September 15 and 16, 2018 which is one of the Work Plan Goals for FY2018-19. The Parks & Recreation Commission reviews and makes recommendations on aspects of the festival including: entertainment; beer, wine, token and commemorative glass selection, quantities, pricing and service locations; Commissioner assignments; charitable organization volunteer assignments and fund distribution; and event promotion.

### **DISCUSSION**

The Parks & Recreation Commission will discuss and evaluate the 38<sup>th</sup> Annual Santa Clara Art & Wine Festival and provide recommendations to improve the festival in the coming year. Recommendation for Council consideration of financial grants from event funds raised to charitable organizations will be made at a future Commission meeting.
