### REPORT TO COUNCIL

#### SUBJECT

Letter from Mayor Lisa M. Gillmor recommending Appointment of Vice Mayor Kathy Watanabe as Chaplain

#### BACKGROUND

On June 9, 1998, the City Council adopted Resolution No. 6442 (Attachment 1), pursuant to Section 705 of the City Charter, establishing a procedure for the selection of Vice Mayor and Chaplain for a calendar year.

Per the resolution, the Councilmember serving as Chaplain shall be the most recent outgoing Vice Mayor.

#### DISCUSSION

Vice Mayor Kathy Watanabe is the most recent outgoing Vice Mayor. In Mayor Gillmor’s letter to the City Council (Attachment 2), she recommends that the City Council appoint Vice Mayor Kathy Watanabe to the position of Chaplain until the appointment of a successor Chaplain in January 2020.

#### ENVIRONMENTAL REVIEW

The action being considered does not constitute a “project” within the meaning of the California Environmental Quality Act (“CEQA”) pursuant to CEQA Guidelines section 15378(b)(5) in that it is a governmental organizational or administrative activity that will not result in direct or indirect changes in the environment.

#### FISCAL IMPACT

There is no fiscal impact other than staff time.
