REPORT TO COUNCIL

SUBJECT

Reappointment of Commissioners, Declare Vacancies and Setting of Dates for Interviews and Recognition of Outgoing Commissioners

BACKGROUND

Board, Commission and Committee members are generally appointed to a four-year term (full term), and may serve a maximum of two consecutive full terms. Past City practice has been for the Council to reappoint an existing member or fill a vacancy with a new applicant. If an individual is appointed to fill a partial term, he or she may serve a two additional full terms. Full terms are effective July 1st of the appointing year and expire on June 30th of the fourth year.

4. Set September 18, 2018 as the recognition date for the outgoing commissioners.
