REPORT TO COUNCIL

SUBJECT

Action on Bills and Claims Report (CC) for the period January 18th - January 31st

BACKGROUND

Disbursements made by the City are based on invoices submitted for payment. Prior to payment, staff reviews all disbursement documents to ensure they are reflective of the goods or services provided. Invoices are usually paid within 30 days of receipt of an accurate invoice. As the final step, the City Auditor, or her designee verifies all documents before payment is issued. Payments are issued through accounts payable checks and wire transfers. It's important to note that items that pertain to the Stadium Authority are billed to the Stadium Manager (ManCo) to pay on behalf of the Stadium Authority for Non-NFL events and the 49ers for NFL events.

The Bills and Claims Report represents the cash disbursements required for operations of the City during the period. The report reflects the payment date, invoice number, description of the payment, funding source, and payment amount for all invoices. The budget control is set by the City Council through the budget adoption process.

DISCUSSION

Significant expenditures in this time period include:

- Payment to Northern California Power Agency in the amount of \$16,310,058 for January 2019 all resources bill and Western Restoration Fund.
- Payment to MSR Energy Authority in the amount of \$2,216,279 for December 2018 gas purchase and January to June 2019 MSR Commission expenses.
- Payment to MSR Public Power Agency in the amount of \$1,839,457 for December 2018 Big Horn energy purchase.
- Payment to EDF Trading North America LLC in the amount of \$1,125,079 for gas purchase.

 Payment to PG&E in the amount of \$895,227 for December 2018 and January 2019 gas purchase.

ENVIRONMENTAL REVIEW
