### REPORT TO COUNCIL

#### **SUBJECT**

Action on Reappointment of Commissioners and Declaring Commissioner Vacancies, Setting of a Date for an Application Deadline, and Scheduling of Interviews

#### **BACKGROUND**

Board, Commission and Committee members are generally appointed to a four-year term (full term), and may serve a maximum of two consecutive full terms. In the case where an existing member is eligible for another term, past City practice has been for staff to contact those existing members and request if they would like to be re-appointed to another term. The Council then takes formal action to reappoint those existing members who indicate a desire to serve a second term. If an individual is appointed to fill a partial term, he or she may serve an additional two full terms. Full terms are effective July 1<sup>st</sup> of the appointing year and expire on June 30<sup>th</sup> of the fourth year.

#### DISCUSSION

Given the lack of a formal policy, staff has continued with the past practice of reaching out to the incumbents eligible for reappointment and inquiring if there is a desire to continue to serve a second term. Staff reached out to all those incumbents on March 28, 2019 and the following eight (8) commissioners have indicated a desire to be reappointed for the full term ending June 30, 2023 as their current terms end June 30, 2019:
