#### **SUBJECT**

Action on a Resolution Revising the Council and Authorities/Stadium Authority Regular Meetings Dates for the 2020 Calendar Year [Council Pillar: Enhance Community Engagement and Transparency] Continued from March 17, 2020

#### **BACKGROUND**

On September 24, 2019 the Council set the Council and Authorities/Stadium Authority regular meeting dates for the 2020 calendar year. On December 10, 2019, the City Council adopted a Resolution revising the Council and Authorities/Stadium Authority regular meeting dates for the 2020 calendar year. Pursuant to Charter Sec. 707, the City Council shall hold regular meetings at least twice each month.

#### **DISCUSSION**

Due to the cancelation of the April 14, 2020 and April 21, 2020 Council and Authorities Concurrent meetings, it is recommended that the Council adopt a Resolution revising the Council and Authorities/Stadium Authority regular meeting dates for the 2020 calendar year to reflect the cancelation of the April 14, 2020 and April 21 Council and Authorities regular meetings and to set April 7, 2020 and April 28 as Council and Authorities regular meetings.
