REPORT TO COUNCIL

SUBJECT

Adopt a Resolution in Affirming the City's Commitment to Stand in Solidarity with the Black Community

BACKGROUND

Our country is mourning the senseless killing George Floyd that occurred in Minneapolis on May 25, 2020. The actions and inactions of the police officers involved were deplorable. Police brutality and racism against the Black community has been persistent in both our past and our present. Systemic injustices, racism, and dehumanization are deeply rooted in our society and it was unquestionably unfair and unacceptable when the lives of George Floyd, Ahmaud Arbery, Breonna Taylor, Freddie Gray, Walter Scott, Tamir Rice, Michael Brown, Oscar Grant, and many others were taken as a result of discrimination and inequity. While these are only a few of the lives lost, amongst many more, these lives mattered and Black lives matter.

Santa Clara is a proud multiracial community, and we decided long ago that mutual understanding and respect develops a much healthier, safer, and caring community. It is important for the community to stand in solidarity with Black communities across the country.

DISCUSSION

A Resolution Affirming the City's Commitment to Stand in Solidarity with the Black Community (Resolution) has been prepared for Council consideration (Attachment 1).

This Resolution affirms the City of Santa Clara's commitment to condemn racial inequity in all forms and violence against the Black community by law enforcement in particular. It also affirms the City's commitment to actively listen and learn from the Black community and encourages the greater community to stand together through peaceful exchange and discourse to enact change and move

forward towards a future with more equity and inclusion.
